The Melbourne Summit, organized by previous President **Sandra Neil**, is July 15. The Padua Regional, organized by previous President **Anna Laura Comunian**, is July 26-27. The 68th Annual ICP Convention is August 3-7, in Chicago. The final 2010 ICP meeting is embedded within the San Diego APA convention, ICP's longest standing annual meeting, on August 13.

Deep Roots. Resilience is a "key word" in the life of the **International Council of Psychologists, Inc., nee. National Council of Women Psychologists, December 15, 1941.** Creative problem solving and innovative solution finding continues to facilitate survival of the ICP core value for each person's **individual right to a healthy, productive life** experience. From an initial shared vision of **world peace**, the association was formed to promote the **application of psychological knowledge** and skill to assist persons whose fathers, brothers, and sons were sent beyond their national borders to the east and west into international war venues. They battled for human wellbeing, to protect individuals from rampant narcissistic prejudices and grandiose empire building. Sixty-nine years, four major wars, and scores of lesser conflicts later,

ICP continues its international quest to share evidence from scientific and methodologically collected information from all cultures that promotes optimal development of each person's unique potentials.

Perseverance. Through economic downturns and professional association proliferations, the commitment to the concept of face-to-face, **person-to-person dialogue and friendship** continues. At a time when membership is at the same level as it was in 1942, ICP ushers in a new era and brave gambit via this **Volume 50, No. 2**, of the *International Psychologist (IP)*. The *IP* newsletter was first issued quarterly in 1951 and was followed by a second, proceedings-like publication in 1956, the *International Understanding. IU* contained ICP papers presented at annual APA conferences. A 1966 merger of the two publications was named the *International Psychologist*, which was considered the most informative conveyor of international news during the final decades of the 1900s. ICP ELECTION 2010 PROCESS

The election process for electing the 2010 ICP Board members enables the election results to be received my prior to the August 3-7 68th Convention and before I depart on my July-August travel schedule:

1. The ballot has been prepared by myself in accordance with past models. I am calling for the following votes: one President elect for a one year term, one Secretary for a three year term commencing summer 2011 which permits a year as Secretary-Elect, and four Directors at Large for a three year term.
2. The ballot contains a vision statement and a photo of each candidate.
3. Ballots are published through IP and in the same manner as the sending of the IP: individually-

transmitted e-mails and by mail to members with no email address.

5. If send by email, to protect confidentiality, send as an attachment. Attachments will be filed until all ballots received by due date and emails deleted. If send by surface mail, please enclose ballot inside a sealed envelope, inside the envelope.
6. Once all ballots are received, copies of these will be send to the other members of the Election Committee: Dr Florence Denmark and Dr Charles Spielberg for counting.

7. **The deadline to receiving ballots is 20th June 2010. No late submissions will be able to be accepted.**
8. Outcome of elections will be presented at the September conference in Chicago.

Please, remember that your vote is very important to ICP and it is your active participation in elections and activities that will guide ICP to greater world visibility and professional effectiveness.

DIRECTOR AT LARGE CANDIDATE: SUBHAS CHANDRA

I hereby apply for one of the positions of Director – ICP and make the following submission in support of my application.

I became a member of the ICP during my attendance at the ICP Conference in Shinjuku, Tokyo in 1990 where I spoke about the provision of psychology courses at the University of the South Pacific (USP) in Suva, Fiji. At that time I was a member of staff and acting Head of the School of Education at USP. My membership of ICP lapsed after I migrated to Australia to work for the Catholic education system. In 2007 I attended the ICP Conference in San Diego and conducted a workshop on behavior modification as well attending the entire conference.

At present I am the Professor of Education and Head of the School of Education at the newly established Fiji National University (FNU). We offer psychology courses in the teacher education programs at the diploma and degree levels. I have taught psychology at the undergraduate and post graduate levels in Fiji and at

universities in Australia. I proposed and was successful in the establishment of the Department of Psychology at USP and plan to do so at FNU. My research has been in the areas of clinical psychology, social psychology, educational psychology and developmental psychology. I have published in international, regional and local journals.

I am well placed through my academic qualifications, teaching and management experience and clinical work to make significant contributions in policy formulation and implementation for the ICP for its future development. The contribution of psychology as a discipline to the maintenance and promotion of quality of life for communities would be the key goal of these policies. Needless to say there is considerable scope for this professional contribution in government policies in the developing world.



Psychology as a discipline must have a prominent place in several international NGOs such as the UN, WHO, ILO and so on. It would be the role of the Directors to negotiate this membership so that psychologists can play some significant role in research, training and project

implementation and evaluation at the national level in many countries. In summary the ICP must adopt policies and practices that are unreservedly endorsed by its members and has abundant scope to attract new psychologists into the organization.

DIRECTOR AT LARGE CANDIDATE: MERIMA ISAKOVIC

Merima is a Clinical Psychologist. She lives in Auckland, New Zealand where she completed her psychology studies. Merima holds Doctoral Degree in Psychology from Victoria University of Wellington, PgDipClinPsyc from Massey University and Certificate of Proficiency for Advanced Biomechanics from University of Auckland. She is currently working full time for CMDHB, Adult Mental Health Services at Middlemore Hospital, Auckland, where she is the single Clinical Psychologist at the Acute Inpatient Unit that accommodates 65 clients. She is also a director in her private practice: Takapuna Psychology Ltd and holds two contracts, one with the Waitemata DHB, working for Child Helath Services, and other with ProCare New Zealand, working with families, couples and adults of all ages.

Merima’s family originate from Bosnia and Herzegovina (former Yugoslavia). She lived in Yugoslavia until the age of 20, when she experienced severe spinal injury that interrupted her, at that time extremely successful career as theatre and movie actress. During her long years of rehabilitation she developed strong interest in psychology and rehabilitation science. Merima’s focal interests are in improved mental health of children, adolescents and acutely disturbed adults. She is strongly committed to rehabilitation psychology that aims helping people with ambulatory and behavioural difficulties following traumatic injury that resulted in complex presentation of neurological damage and behavioural change. Merima truly believes that “life is a gift and it can always be even better!” After her husband passed away, she lived in New

Zealand together with her son (now 23-year old) who she is proud of. She believes that family is the most precious treasure and that all human experience and knowledge needs to serve people and help them to grow healthier and happier families.



Merima is a passionate researcher and presented her research at various national and international conferences. She is a member or executive member of multiple national and international associations. She is the Area Chair for New Zealand and Principal Research Coordinator/IP Editor for the International Council of Psychologists (ICP) as well as the Executive Member of the Aotearoa New Zealand Association for Cognitive Behavioural Therapies (AnzaCBT). Merima is a member of the New Zealand College of Clinical Psychologists; New Zealand Psychological Society; New Zealand Spinal Society; The New Zealand Rehabilitation Association; New Zealand Brain Injury Association; Positive Psychology; Association of Humanistic Psychology; United Spinal Association and International Spinal Society. She is involved in charitable works that help people with disabilities to re-gain their independency and re-establish creative and fruitful life. Merima has strong commitment to research-based clinical practice as well as to the practice-based research. She has strong leadership skills, rich international scientific network and ability to grow fruitful network in a warm friendly as well as professional manner.

DIRECTORS AT LARGE CANDIDATE: TARA PIR

I share the mission and values of ICP. If elected for the position with the support of ICP members, I am committed to do the following:

- Contribute to the spirit of creativities, collaboration and engagement within the ICP board and between

Christine Schwarzer is full professor at the School of Education of the Heinrich-Heine-University of Düsseldorf, and head of the department of Adult Education and Educational Counseling.

She started her career in 1967 as a teacher for Special Education, and got her PhD in 1975 at the University of Kiel in the domains of education, psychology, and child psychiatry. Her university career began at the Institute for Special Education of the University of Kiel as teaching and research assistant. From 1976-1983 she worked at the University of Cologne as an assistant professor. After her habilitation at Cologne-University in 1983, she got her

current position as full tenure professor at the Heinrich-Heine-University of Düsseldorf. She served as dean and is head of the commission on international partnerships of her university. She is a member of STAR since its foundation and during the last 2 years president of the Stress and Anxiety Research Society (STAR). She is member of the European Association for Research on Learning and Instruction (EARLI) and several German Associations. Her research topics are social support, psychosocial well-being in the elderly, burnout, and stress in international Settings.



DIRECTORS AT LARGE CANDIDATE: ANGES CHANG

The need for psychological knowledge and the application of such knowledge to the emotional healing of victims of natural disasters in Sichuan, Qingdao and Haiti and of victims of man-made disasters like the financial tsunami, alert us to the responsibilities resting on psychologists in this challenging time, especially in the

developing countries. Many of the developing countries where these disasters occurred, have few trained psychologists. Hence there is a need for us to extend a helping hand to the training of psychological aides in these countries.



DIRECTORS AT LARGE CANDIDATE: NEAL RUBIN

Neal Rubin, Ph.D., ABPP is Professor and University Scholar at the Illinois School of Professional Psychology at Argosy University, Chicago and Assistant Professor of Clinical Psychology in the Department of Psychiatry at the University of Illinois at Chicago. He is a board certified diplomate in clinical psychology with the American Board of Professional Psychology and Fellow of the American Academy of Clinical Psychology. Dr. Rubin is a Fellow of

the American Psychological Association and is an elected member of the Executive Board of the Division of International Psychology. Since 2003 Dr. Rubin has served as a Special Projects Associate of the APA's United Nations NGO Team in New York City, which facilitates the role of



psychological science in addressing the United Nations' human rights agenda. His interests are in human rights, peace and peacekeeping, trauma and promoting the roles of psychology and psychologists on the world stage.

This year I have been working with the local arrangements committee for the ICP Chicago conference, proposing programs and speakers to bring together local Chicago area psychologists and students with ICP members. If elected I would be interested in continuing

to encourage the involvement of students and early career psychologists in ICP while maintaining the traditions of excellence previously established in scientific and professional endeavors. I would support the efforts of the ICP President and the Board's vision for the sustainability of ICP as a viable and significant 21st century international organization. UNITED NATIONS NGO MAIN REPRESENTATIVE FLORENCE DENMARK PRESENTS ICP ENDORSED REPORT ON

“Implementing the internationally agreed goals and commitments in regard to gender equality and empowerment of women”

A UN study indicated that internationally agreed goals and commitments are largely silent on older women and the implementation of those [goals] that do address older women has been inconsistent at best. When this Report and associated UN action is adopted, it is hoped that the general recommendation on older women’s rights will outline the content of the obligations assumed by States parties from the perspective of ageing and provide guidance to both State parties and NGOs on inclusion of older women’s rights in their implementation of, and reporting on, the Convention. The Report is as follows:

Introduction

1. This submission focuses on the extent to which older women and ageing have been taken into account in the implementation of key international commitments and goals on gender inequality. It finds that ageing and discrimination against older women are rarely considered and argues that it is imperative to respond to the gender implications of population ageing if gender inequality is to be adequately addressed. Finally it makes recommendations for action to take this forward.

The century of ageing

2. The 21st century is the century of ageing. Populations are ageing at an unprecedented rate: the proportion of older people is predicted to rise globally from 760 million today (11 % of the population) to almost 2 billion by 2050 (22% of the population). By 2045 there will be more people over the age of 60 than children under 15 . Whilst already well advanced in some developed countries, population ageing is happening most rapidly in developing countries.

Women and ageing

3. Whilst global statistics mask the very different contexts in which older women live, they do serve to illustrate the gendered nature of ageing. More older women than older men live alone, with 19% of older women compared to 9% of older men living on their own. Whilst for some

older women this may be a lifestyle choice, for others it can lead to isolation and be a barrier to accessing support and services. Similarly, 80% of men over 60 are married compared to only 48% of older women. There are more women living into their 80s and beyond: whilst there are 83 men for every 100 women at the age of 60, there are only 59 men for every 100 women at the age of 80.

Older women and gender equality

4. Men and women experience ageing differently. Both experience discrimination based on old age but, for older women, this can be exacerbated by a lifetime of gender-based discrimination, poverty and of working in poorly paid jobs with little access to formal social security to provide a regular income for them in old age.

5. Older women are not a homogenous group. The discrimination older women experience is often intersectional, their old age compounding other forms of discrimination based on gender, ethnic origin, disability, marital status, levels of poverty or literacy. Often considered no longer economically or reproductively useful, many older women are seen as a burden on their families and communities, are marginalized, isolated and even abandoned. Despite this, older women’s contribution to society – as careers, advisors, mediators and breadwinners – is invaluable.

Older women and internationally agreed commitments and goals

6. Demographic ageing is having a profound effect on the society in which we live. Policies across all sectors need to respond to its implications, including those related to gender equality. However, internationally agreed goals and commitments are largely silent on older women and the implementation of those that do address older women has been inconsistent at best.

The Beijing Declaration and Platform for Action

7. The Beijing Declaration and Platform for Action addresses older women’s poverty, health, violence against them, obstacles to entering the job market, vulnerability in armed conflict.

THE 13TH INTERNATIONAL SYMPOSIUM ON VICTIMOLOGY

Dr. Machiko Fukuhara (Japan)

A Report on The 13th International Symposium on Victimology held in Japan.

The 13th International Symposium on Victimology, sponsored by World Society of Victimology was held in Aug. 23-28, 2010 in Mito City, Ibaragi Prefecture, Japan. Tokiwa University hosted the meetings. The theme of this Symposium was "Victimology of Human Security."

Starting with the opening ceremony where HRH Princess Baarakitiyabha, Thailand, spoke, the program consisted of 8 keynote sessions, 35 parallel sessions, 35 poster sessions as well as social hours were proceeded. Approximately 500 participants were from 47 area of the world. Students and scholars of young career especially from Asia were encouraged to participate.

Machiko Fukuhara, served as an advisory committee member and as organizer of the only invited parallel session. The theme of this session was "Psychological and Psychotherapeutic Interventions for Victims on the Basis of Microcounseling." Five speakers talked about his/her approach of serving the victims (individual and /or group) and its contribution to society/the world, respectively in line with Fukuhara's introductory comment on to the theme which follows. Recently people in the world are facing various types of unstable situation which lead them to becoming victims. A variety of obstacles, such as bio-socio-psycho factors are often involved. Many of those people are victimized regardless of their degree of symptoms, whether moderate or severe. Often they can be helped so that they become healthy enough in order to maintain their 'Wellness' lives. According to a definition by authorized institutions, "Wellness is summarized as one's state of overall health including psychological

health." Individuals have the right to be healthy and to be protected from being victimized, as well as free from negative situations they affect their health. ' Helping Relationships' to serve those individuals are sought among professionals, Para-professionals, and /or volunteers. "Giving psychology away" is a common phrase among psychologists and psychotherapists. Especially since the middle of the 19th century they have been encouraged to generalize their theories, as well as practical skills to laymen at large who wish to be healthy. Thus, this makes a contribution to society. Microcounseling, which provides basis for counseling/psychotherapy, and psychoeducation is considered as one of the most appropriate and satisfactory approaches for the fulfillment of this purpose.

Dr. Jose-Maria Prieto, Officer, International Association of Applied Psychology who happened to be visiting Japan was cordially invited to this parallel discussion and was appreciated by presenting his thought on it from the viewpoint of his experience of disasters in Spain, his country, Another presenter from abroad was Dr. Ishiyama, Associate Professor, British Columbia University, Canada. He spoke on the theme from his experience of living in a non-native culture and also on his study of Morita therapy. Both presentations contributed to enlarging multicultural view of human beings for their mental health. The other speakers (Japanese) spoke on Eclectic therapy, Behavioral Medicine and Health Psychology respectively.

This Symposium is being held every four years somewhere in the world. It was held in St. Antonio, Florida in 2005.

AUSTRALIAN ABORIGINAL HIGH ART

Aboriginal Australian Art are produced by Indigenous Australians, covering works that pre-date European colonization, as well as by contemporary art by Aboriginal Australians based on traditional culture. Art is one of the key rituals of Aboriginal culture and was and still is, used to tell stories about the Dreamtime. The Dreamtime for

Aboriginal people is the time which the earth received its present form and in which the patterns and cycles of life begun. "Dreamtime is often used to refer to the 'time before time' or 'the time of the creation of all things, which 'Dreaming is often used to refer to an individual's or group beliefs". According to Morphy (1991), The designs are an integral part of the ancestral beings

themselves---The designs themselves possess or contain the power of an ancestral being. Many paintings representing a 'dreamtime story" are shown from an aerial perspective. The narrative follows the lie of the land, as created by ancestral beings in their journey or creation. Whatever the meaning, interpretations of the

icons should be taken in the context of the entire painting, the region from which the artist originates, the story behind the painting, the style of the painting, with additional clues being the colors used in some of the more modern works. 5/11/10 Joan Fimbel DiGiovanni, Ph. JANET SHIBLEY HYDE WINS ICP'S DENMARK-GRUNWALD AWARD ON GENDER STUDY!

The 2010 Denmark-Grunwald Award will be presented to Dr. Janet Hyde, who will give an invited address at the Chicago convention in July. Dr. Hyde's talk is titled "Developmental Trajectory of a Feminist Psychologist." In the talk she will trace her career from her early research in mouse behavior and genetics to her current research areas in the psychology of women and human sexuality. I hope that many of you who attend the convention will come to hear her talk. She is a lively lecturer; you will not be disappointed!

Janet Shibley Hyde earned her B.A. degree in mathematics from Oberlin College and her Ph.D. in psychology from the University of California at Berkeley. Denison University named her an honorary Doctor of Social Sciences in 1996. Dr. Hyde is the Helen Thompson Wooley Professor of Psychology and Women's Studies at the University of Wisconsin at Madison. She has served as Chair of the Department of Psychology, Director of the Women's Studies Research Center, and Associate Vice-Chancellor for Academic Affairs at UWM, where she has worked since 1986.

Dr. Hyde is perhaps best known as the author (or editor) of 10 books, including her best selling textbooks *Half the Human Experience: The Psychology of Women*, which is currently in its 6th edition, and *Understanding Human Sexuality*, which is currently in its 10th edition and

has been translated into Spanish and Chinese. She has also published nearly 150 journal articles and book chapters in her areas of expertise. She has published several much cited meta-analyses of psychological, cognitive, and behavioral gender differences. That work led to her award-winning *American Psychologist* article "The Gender Similarities Hypothesis." Among Dr. Hyde's research interests are depression, body satisfaction and objectification, women in math and science careers, feminist identity development, work-life balance, and sexuality and sexual satisfaction. Dr. Hyde served as Editor of *Psychology of Women Quarterly* (1986-1989), and she has been a member of a number of journals' editorial boards. She has been elected President of the Society for the Scientific Study of Sexuality and of APA's Division 35 – the Society for the Psychology of Women. She has been a member of many boards and task forces in other organizations, notably the PsycINFO Advisory Board (APA) and the State of Wisconsin Governor's Commission on the Glass Ceiling.

Dr. Hyde has had many grants to support her research, has been honored many times for her scholarship and leadership, and has been a Distinguished Visiting Professor at the American University in Cairo. She has truly made outstanding contributions to the psychology of women and gender.
