MESSAGE FROM THE TREASURER

Dear Friends and Colleagues,

Currently ICP has a balance of \$4,732.22 in the Convention Account and \$65,348.45 in the Operations Account. On March 11, 2011 ICP filed the 2010 IRS Tax return prepared by the Treasurer. ICP has collected \$5,270.00 in 2011 dues.

Fifty one came from Country A, three came from Country B, ten came from Country C and there are six students who have paid. This includes Dr. Pir's colleagues' membership which she paid for their first year. She also paid for three students. The remaining three students were renewals.

In addition, ICP paid \$365 to APA for CE Sponsorship. ICP's contract with the Capital Hilton is progressing slowly but should be in place next month.

The spring ballot will be released during the first week in May. I remind the membership that in order to vote members must be in good standing and be current in their dues payment.

The Treasurer assisted in the formation of the membership database, assisted in the transfer of the web-services from TCS to Dr. Beverly Stevens, assisted in updating the PayPal HTML codes for various pages, and met with the President to discuss financial matters and bank statements and to plan up-coming events. Also the Treasurer assisted the Past President with ensuring an up-dated e-mail list for the Spring ballot.

As you know, the first call for 2011 dues was sent out in October 2010. A second call for dues was initiated in December. Also, as of December 15, a late fee was imposed raising the dues fee to \$115.00. This \$15.00 late fee was imposed to encourage individuals to pay dues early so that the Executive Committee could propose a 2011 budget.

As of today, slightly more than 18% of the ICP membership has paid their 2011 dues. 18%! No organization that receives **all** of its revenue through dues can survive on 18% of the membership. It is obvious to some that the membership has spoken.

Finally, on a personal note, I am currently involved in funding a research proposal that will take me to Japan for radiological research which is my specialty. As a result of my impending additional workload, I am making this call for an Assistant Treasurer to lighten my ICP responsibilities and to possibly to take over the position entirely.

An insider's report from disaster stricken Japan

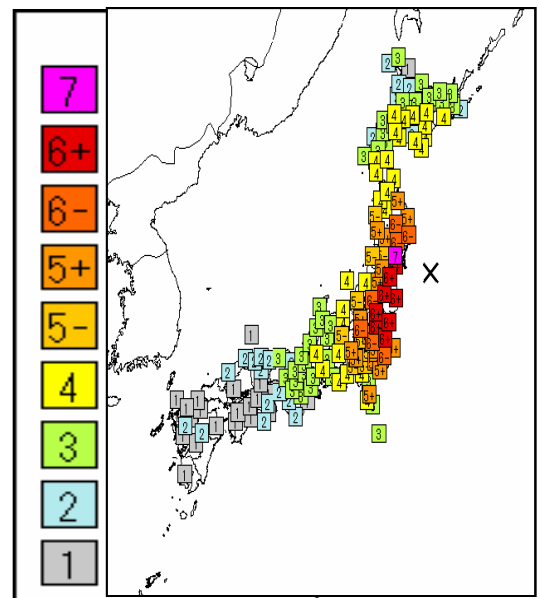

One month has passed since the massive earthquake hit Japan at 14:46 on Friday, 11 March 2011, off the Pacific coast of the northeastern part of the main land (Tohoku Region), causing devastating damages. It was a mega-earthquake of magnitude 9.0, the largest earthquake ever recorded in Japan and the 5th largest in the world. I and my husband just entered our home after a business trip when the ground started shaking. Instead of getting weaker, as we by experience thought it would, the shaking got stronger and stronger this time, until everything was shaken off from the table, shelves and walls. The tremor lasted 6 long minutes, it seemed as if it would never stop! In Tsukuba in Ibaraki prefecture, where we live, the strength of the shaking reached 6 on the shin do scale (which is the degree of trembling with 7 as the highest possible value, not to be confused with magnitude!). We ran out to the parking space not be hurt by falling objects indoors, and saw our car swaying like a small boat on the stormy ocean. I have never experienced such a strong and frightening earthquake! We feared that the ground would split and we would fall into the hole!

When the first quake settled and I was cleaning the broken stuff in our home and wiping the floor after a flower vase full of water fell down, the next tremor came just after 10 minutes, at 15:08, of magnitude 7.4, then a new one of M 7.7 seven minutes later at 15:15, and another one of M 7.5 ten minutes later at 15:25. Everything that was not shaken off and broken in the first tremor, surely did during these strong aftershocks! As the electricity and water supply were immediately cut off, we couldn't stay in our home, so we spent the first night in our car at the parking space of a convenience store, scared and tired, but relatively safe.

As Tsukuba is not situated along the coast, we were luckily not affected by the tsunami, which hit the east coast after the earthquake with waves over 10 m high. The enormous waves wiped out several towns and killed over 10.000 people. Many are still missing. During this past month, there have been over 1000 aftershocks of which 423 were over magnitude 5 or greater (72 were M 6 or greater and five were M 7 or greater). Several of these aftershocks resulted in new tsunamis as well.

Now, the mega-earthquake and mega-tsunami already left tremendous damage behind, but misfortune never comes alone. After the earthquake and tsunami disaster, a new and even more frightening accident occurred. The over 10 m high powerful tsunami waves greatly damaged a nuclear power plant in Fukushima and cut off its electric supply, which caused the cooling system of the reactors to stop functioning. This has resulted in overheating of the reactors, explosion and radioactive leakage from the plant. For the past month workers have been working under extremely dangerous conditions, risking their health and life, to stop the leakage and repair the plant. Some progress has been made, but the situation is far from safe. The area within a 20 km radius has been evacuated, but radioactivity can travel quite far with the winds, affecting the air, agricultural production and water even in places further away. There have already been reports about contaminated vegetables, milk and water as far as 150 km from the nuclear plant. The consequences are far greater than anyone would ever have imagined.

I am one of the lucky people who have stayed alive, did not lose family or friends, and had only minor damage to our home. However, there are several hundreds of thousand people who lost their homes and families, parents lost their children and children lost their parents. More than 100,000 people still live in evacuation centers after more than one month, lacking privacy and the possibility of laundry, bath and other every day necessities, as well as emotional support.

After going through a life-threatening experience like the triple disaster of the Great East Japan Earthquake, many people can be expected to acquire stress-related ailments. Although it is said that the majority recovers within about a month, the scale of the disaster - which left about 28,000 people dead or missing and about 5000 injured - may have caused so deep mental trauma that a much longer healing time is needed. Even those with no immediate signs of trauma are at risk of developing symptoms months or years later, experts say. Under such circumstances it is extremely important that we psychologists reach out our hands and offer our help to the victims of the disaster.

Japan has always survived catastrophes and crises, and I know that it will do that again. And I hope I can be one of those who contribute to rebuilding this country and supporting its people.

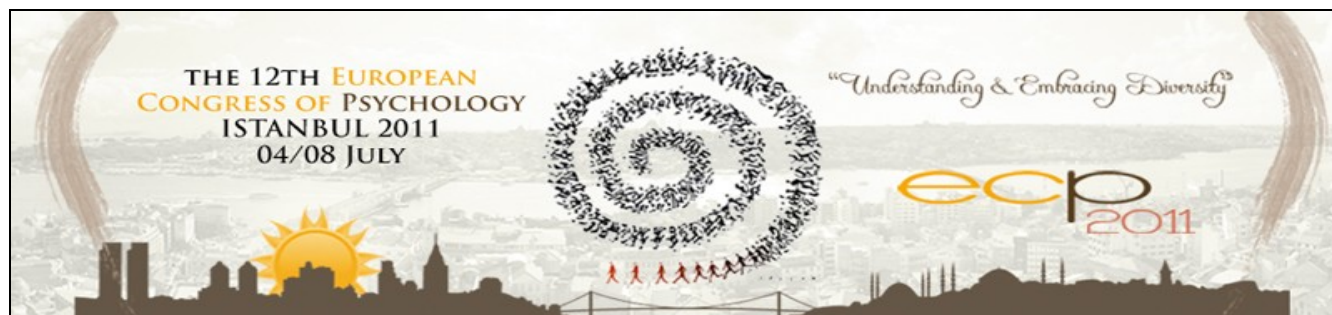

The Chicago School Pilot Year March 1, 2010 –March 1, 2011

ICP OPERATIONS DURING 2011 : Self –Management. IP & Web Contracts

The proposal the ICP Executive Committee submitted to The Chicago School [TCS] for a second year of association was not confirmed. ICP's Executive Committee as authorized by the Board of Directors proposed modified agreements to TCS. TCS chose not to respond to that proposal.

Based on decisions of the August 2010 Board, 2010 Bylaws and mission statement revisions [Membership vote, Oct 2010], and financial constraints related to reductions in dues paying membership constituencies, most functions are being managed by the Member-in-Charge. The Board of Directors discontinued the Secretariat for the immediate future and called for Members to cover duties related to their roles and to enlist new members from allied disciplines.

The bylaws now recognize two ICP membership categories: Member and Student. All professionals accepted for membership will enjoy full benefits and privileges as long as they remain Members in good standing [current dues paid].

Dr. Sayaka Machizawa discontinued her services to ICP February 28. She is planning a marriage in July. Ms. Amrita M Utamchandani, the graduate student who developed the updated ICP brochure, writes that she plans to continue a professional relationship with ICP. Nate Smith who handled the website with Dr. Gamache has turned over the role to Dr. Bev Stevens. ICP expresses appreciation for the support and time given by those assigned by TCS to carry out the Pilot Year Agreements.

Dear Ann,

Re: Big Earthquake and Tsunami

Thank you for your kind message of March 18 that tells that you are worried about my safety and health.

I am safe in Tokyo but the aftermath of the tragedy continues to threaten me with aftershocks, lack of water, lack of food, rumor of radiation, etc. We have to save electricity. We are uneasy about economics. Certainly I am sad when I read newspapers every morning, thinking of the people in the area suffering from this tragedy. We have colleagues living in the direct area and I am doing small things which I can to help them.

The University I work for as an honorary professor, had heavy damage, and they were obliged to cancel commencement ceremony in March.. We are concerned with students or people from abroad living in community/ Japan for their safety and mental health. Psychologists (as individual or as group) are starting to take action to help.

For now, Listening to them for their need seems to be helpful before they touch with their traumas.

This historical tragedy influences people of all over Japan. While, we feel we ourselves need more detailed / clear information from the authorities. Otherwise we will not be able to solve problems in hand in right way meeting with people's needs. I feel that, as is said, Japanese people tend to depend on 'self-help'. But I feel that we have to know more and to send more information accurately to overseas, too.

I am hoping to go to Washington, DC for APA and ICP.

ICP BOARD OF DIRECTORS DECISION-ACTIONS SPRING 2011

Ann Marie O’Roark, President 2009-2011

The ICP Executive Committee is charged with decision making during interim periods between Board annual meetings. Two major considerations were sent to the full Board of Directors in April and May:

1. A majority of Board members [9] sent votes regarding the following KGAI proposal for supporting research at the Fukushima Dai-ichi Nuclear Plant in Japan. Eight votes supported the proposal, one sent concerns. The recommendation is to provide the refunded APA CE fees [\$365] to enter into an agreement with KGAI.
2. In response to a called voted for embedding the ICP annual meeting within the IUPsyS Congress in Cape Town, South Africa, eleven Board members voted, unanimously YES to the generous offer from IUPsyS’s Congress Organizing Director, Seth Cooper. The IUPsyS meets every four years and its logo is ICP2012.
3. The Board voted to submit an amended proposal to The Chicago School for services and fees for March 2011-2012. This proposal has not been responded to by liaisons from TCS. [See report included earlier.]

Dear Dr. Tara Pir,

Thank you for your email.

As you are aware, five months ago I suggested that your 70th ICP convention could piggy-back on our 30th International Congress of Psychology, instead of your having to organise a completely separate event that will entail costs, organisation and logistics. I detailed then the benefits associated with such an offer, which, for ease of reference, I repeat below.

The first International Congress was held in Paris in 1889 and the last was held in Berlin in July 2008. The 30th Congress is organised under the aegis of the International Union of Psychological Science (IUPsyS) which represents national psychology associations or country members, and does not afford individual membership, unlike other bodies like the International Association of Applied Psychology (IAAP) and the Council.

The next Congress will be held at the International Convention Centre, Cape Town (CTICC) from [22 to 27 July 2012](#), and, as it's a long-haul destination, we are targeting 7,000 delegates from around the globe. Under the theme "Psychology Serving Humanity", the Congress will showcase new frontiers of psychological science and practice as a means for improving, developing and enriching human life. The scientific programme will feature distinguished keynote addresses, cutting edge state-of-the-science/arts lectures, controversial debates, and compelling presentations by leaders in the various fields of psychology. Already some 300 leaders in their fields the world have confirmed their participation in Invited Addresses, Symposia, State-of-the-Science Lectures and Workshops. Martin Seligman is the Opening Plenary Speaker. *Inter alia*, Elizabeth Loftus and Michael Rutter will present State-of-the-Science Lectures and Keynote Addresses. Abstract submission from psychologists everywhere to present podia, interactive poster and symposia presentations will close on [1 December 2011](#).

Registration fees are categorised into High, Medium, Low Income, Student and Accompanying Persons. There are three reduced fee dates, the first being [1 December 2011](#) and the last being [1 April 2012](#). The fees are more affordable than the last ICAP held in Melbourne and the next European Congress to be held in Istanbul [this July](#). There is an exciting Emerging Psychologists' Programme that young psychologists will be enrolled into on an individual application basis, as well as at least three Advanced Research and Training Seminars (ARTS) of up to three days each that is geared at developing world psychologists that IUPsyS, IAAP and the International Association of Cross-Cultural Psychology (IACCP) jointly sponsor and organise around the time of the International Congress. The IACCP will hold its 21st International Conference as a pre-Congress event from [17 to 21 July](#) at the University of Stellenbosch (part of the Cape Town Metropolitan area).

[ICOPE Letter, con't.]

The 5th International Conference on Psychology Education (ICOPE, previously Teaching Psychology) will be held as a distinct track in the Congress while retaining its organisational integrity. The Psychological Society of South Africa (PsySSA) will subsume its Annual Congress within the International Congress and will hold its Annual General Meeting of Members during the Congress at the CTICC. The same will apply to other organisations like the South African Clinical Neuropsychological Association (SACNA) and the South African Aviation Medicine/ Psychology grouping. Members (or potential delegates) of these organisations would pay only the Congress fees and no other addition, and would have the advantage of going to other sessions especially when their organisation's track is exhausted. These organisations would also enjoy the benefit of recruiting new members from a very large base the world over.

The Congress hosts are the National Research Foundation of South Africa (the statutory adhering body for South Africa with IUPsyS) and the Psychological Society of South Africa, with host partners including the Psychological Association of Namibia, the Zimbabwe Psychological Association and the Mocambique Psychological Association. Academic partners include the Universities of Cape Town, Monash, Nelson Mandela Metropolitan, North-West, Pretoria, Rhodes, South Africa, Stellenbosch, Walter Sisulu and Witwatersrand.

The following are the options that you in the Council have:

To proceed, convening a Long Range Planning Committee that will be charged with the logistics and costs of organising a separate pre or post-Congress event in the Cape Town area in [July 2012](#), OR

Avoid the costs and organisational challenges (such as having to pay for Professional Convention Organiser and other services) associated with holding a separate convention by doing what ICOPE and others mentioned above have done.

The essential elements of our offer are that:

1. Your Council convention be allocated a distinct track in the 30th ICP Scientific Programme while retaining its organisational integrity.

The Council appoints an abstract review committee of not less than five psychologists, one being chair and another being co-chair. This committee will be responsible for reviewing of abstracts relevant to your track, and that will be electronically submitted through our website <www.icp2012.com>. From the email communication that I was copied on, it seems that there are eminent names for such a scientific committee to be constituted and which could include your Long Range Planning Committee. The 30th ICP 2012 requirement for at least two young emerging psychologists to be on each topic committee will be waived. All Council abstracts will go directly to this committee for review, with the final notification of abstracts deadline being [1 March 2012](#). A detailed note from our webmaster will be sent to members of this Council committee to enable their easy use of the abstract review management system.

1. We'll assume responsibility for the costs associated with your members' (and any other submitter's) use of our abstract management system and the costs for promotion and organisation of the 30th ICP 2012.
2. The Council uses its good offices to promote its convention within the larger 30th Congress. The Council would either provide us with an email database of members and other contacts for sending appropriate electronic communication about the Congress and the Council's involvement thereof or would do so itself.
3. The Council provides a logo that will be put on the Congress website to identify and publicise the Council and to direct viewers to the Council website for specific information about the Council.
4. Council members will be entitled to benefit from the wide range of quality hotel accommodation, cost-effective air flights, and great tours on offer.

Should our generous offer detailed above not meet your requirements, please indicate ASAP as time is moving on. We go into print with the Final Announcement and Call for Abstracts on **1 June** this year.

I shall gladly revert with any further information that you may require. In addition, I shall be attending the APS Convention in Washington, DC from the 26th to the 29th of this month should you and other Council leaders wish to discuss/clarify anything.

Proposal to the International Council of Psychologists, Inc.

This proposal from KGA International (KGAI), a psychological consulting firm with specialization in nuclear research invites the International Council of Psychologists, Inc. (ICP) to co-sponsor the following research with KGAI: “***Finding Scientific Solutions for Workplace Disasters***”
ASSESSMENT AND REHABILITATION OF WORKERS EXPOSED TO IONIZING RADIATION FROM THE FUKUSHIMA DAI-ICHI NUCLEAR POWER PLANT IN OKUMANCH, JAPAN

KGAI International (KGAI) is developing a research study to establish evidence based upon information useful in developing services that can enhance the health and wellbeing of workers exposed to the effects of ionizing radiation due to the natural disaster impacting the Fukushima Dai-ichi nuclear Power Plant. The study will focus on three experimental groups of civilians who received doses of ionizing radiation above background radiation, and one control group.

KGAI Research Design

KGAI's research design for the Fukushima Dai-ichi project extends and elaborates their Chernobyl research design. A major advance in the proposed research is the addition of a rehabilitation phase following, and based upon, the results of physical and cognitive assessment of individuals exposed to excessive ionized radiation.

Investigation Component: KGAI will utilize a computer-based Automated Neuropsychological Assessment Matrix (ANAM) developed by Dr. Dennis Reeves and the Gamache Physical Abilities Battery (GPAB) developed by Dr. Gerald Gamache.

Rehabilitation Component: The rehabilitation portion of the project will utilize a program similar to that used by Coastline Community College in their Acquired Brain Injury (ABI) Program. Dr. Dan Levinson uses this program of rehabilitation with veterans suffering from Post-Traumatic Stress Disorder (PTSD) and Traumatic Brain Injury (TBI).

1. The Fukushima Dai-ichi project design will specify a sequenced time-task methodology for performing several phases of the scientific investigation. The process recommended by the International Testing Commission for translating all documents and assessment instruments into Japanese will be followed. Once completed, a pilot testing of the translated protocols will be performed to ensure understanding, appropriate back translations, and readability.

Selection. Workers employed at the Fukushima Dai-ichi facility will be invited using informed consent agreements. The two other groups will be composed of non-plant workers (Japanese populations) who received radiation doses in excess of back-ground radiation. Those who agree to participate will be assigned to one of three categories based upon amount of ionized radiation exposure. A control group composed of Japanese individuals not exposed to radiation will be invited to participate in the investigation. All groups will be matched in terms of occupation, education, gender, and age, so that the only differential is exposure.

Method. The first assessment battery administered will establish a baseline for later statistical analyses.

Each group will be compared to its previous test performance and compared to the control group test performance. This will be a longitudinal study so assessment will occur over several years.

Rehabilitation. A fourth assessment battery will consist of psychological measures appropriate for treatment and rehabilitation planning, which will be offered initially to exposed individuals not in the experimental/control groups. The final phase will be individual assessment for rehabilitation of the people in the experimental groups. For rehabilitation services, exposed individuals will be assessed using a variety of standardized tests from the Coastal Model successfully used by Dr. Dan Levinson and state-trait assessment measures developed by Dr. Charles D. Spielberger. Rehabilitation services will be individualized according to the needs of the exposed individual.

KGAI EXPERIENCE IN POST NUCLEAR DISASTER RESEARCH

KGAI, formed in 1989, will send its senior research team to Japan for administering assessments. This team performed similar research under contract with the US Department of Defense, completing a ten year research project with survivors of the Chernobyl accident. The KGAI team is headed by Dr. Jerry Gamache, former Director of the U. S. Army Safety Studies Program in the Pentagon and the U. S. Army Safety Center. Team researchers are: Dr. Dan Levinson, research professor at Alliant International University, Los Angeles, Irvine Campus and a clinical psychologist, Dr. Dennis Reeves, retired Commander, U. S. Navy Medical Service Corps who is a consultant for the National Intrepid Center of Excellence (NICOE), which was established to assist Iraq and Afghanistan veterans.

KGAI pioneered scientific-psychological research that combined physical and cognitive decrements in performance related to exposure to ionizing radiation. This KGAI research team received the National Academy of Neuropsychology's prestigious Nelson Butters Award for contributions to neuropsychological research.

KGAI anticipates funding for the Fukushima Dai-ichi project will come from university, professional associations, and organizational entities with stated priority interest in:

Employee health, well-being and productivity,

Scientific knowledge about psychological and mental health

Community action to promote world-wide commitment to support services to assist workers return to full productivity, health and well-being following disasters in high risk workplace environments.

Invitation to Participate in Project Sponsorship

KGA International's approach is confirmatory research. Regardless of the outcomes of the investigation, the Fukushima Dai-ichi practical research will be a win-win situation. If research indicates radiation has detrimental effects for certain workers, this leads to immediate rehabilitation services. Should the research not indicate a negative impact, differences between this disaster and previous similar incidents will contribute to the knowledge base and is beneficial in advising workers exposed to ionized radiation. KGA International will work closely with its prime project sponsors by keeping them informed of research progress.

The Fukushima Dai-ichi research will make a major impact on healthful recovery from this significant 21st century natural disaster and workplace tragedy.
