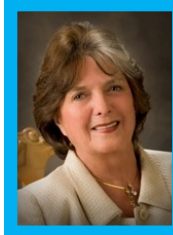

MESSAGE FROM THE PRESIDENT-ELECT

It is a pleasure to accept the position of President-Elect for the International Council of Psychologists. I am grateful for the opportunity to serve such a valuable, long-standing organization in the world. Seventy years of service truly makes us a unique organization.

With a very meaningful transition and transformation, the history of the organization speaks to the high level of commitment and leadership of the ICP members. I am excited to operate in my position on the philosophy of inclusion-by-design in order to promote the global concept of peace and wellness. A broader view of health and wellness brings us from an individual view to a global view. Acknowledgment and appreciation for the notion of health and healing practices across all cultures help us to develop meaningful shared strategies to promote global stability and wellness.

Below is the status of a few items:

- The 70th Annual Conference and annual board meeting for 2012 will take place in Seville, Spain. I will serve as the program chair for the convention's scientific programs.
- I recently attended and presented at the United Nations NGO Convention in Bonn, Germany, entitled: "Sustainable Societies; Responsive Citizens." In line with the mission and vision of ICP, my presentation focused on the integration of mental health and primary care to build global sustainability and introduced my innovative model of mobilized healthcare. As an appointed lifelong ambassador of ICP, I was proud to represent our organization and bring greetings and good wishes from our ICP members and executives to the participants at the UN convention.
- As the Long Range Planning chair and only person, I developed many proposals for venue locations for several countries and presented this during our last board meeting and at the meeting the prior year. Also, since we have changed our mission to include allied professionals, it would be important to coordinate our annual convention with other organizations, as we were planning to do with IUPsyS in South Africa. In this regard, I did a search on international allied and psychology conferences for this year and next and pre-

sented these events to the board for consideration. As I transition into my role as president-elect, I will remain available to our new planning team for support and consultation of effective planning and programming for ICP conventions worldwide.

- As presented at the APA convention, by the year 2014 the ICD is to replace the DSM. As president-elect, I contacted the current president and president-elect of APA about the global standards and implementation. I recommended that we develop a task force in the US to support a smooth plan for clinical application as it applies to US members and worldwide. The international group that presented at APA will present their outcome study at the 30th International Congress of Psychology in South Africa. I will provide an update on the development of the task force.

Please note that the deadline for submission to present at the 30th International Congress of Psychology in South Africa is fast approaching. - Those interested in attending South Africa will meet there so that we can keep our commitment to IUPsyS for a joint collaborative activity, as we have previously agreed.
- We will have a local area meeting in New York around the time of Psychology Day in April for those who will be available to attend.

Also, we plan to incorporate a tribute to former ICP President Uwe Gielen on his retirement at St. Francis College and to his international conference being held shortly following the UN Day.

ANNOUNCING A NEW AWARD



The INTERNATIONAL COUNCIL OF PSYCHOLOGISTS, INC. is proud to announce the establishment of a new award for outstanding contributions to international research and service.

The ICP, Inc. Board of Directors approved the following proposal for initiating the award funded by a gift from Dr. Machiko Fukuhara of Japan, former ICP Treasurer and lifelong member.

The Fukuhara Advanced International Psychology Research and Service Award

EXCELLENCE IN INTERNATIONAL RESEARCH AND SERVICE

This award is given to a midcareer or senior level psychologist with distinguished contributions to international psychology in research and service and is funded through an ICP, Inc. Award Fund established by Dr. Machiko Fukuhara, past Treasurer of ICP, Inc., Organizer of the 1990 ICP conference in Tokyo, research collaborator with past president Charles D. Spielberger on State-Trait Measures of Anxiety, Anger, Curiosity, and Depression. Dr. Fukuhara served two terms on the Board of the International Association of Applied Psychology and is Director of the Japanese Association of Microcounseling, Director of Psychoeducation Institute, and Honorary Professor of Tokiwa University. Dr. Fukuhara epitomizes the standards of excellence that ICP, Inc. and this Advanced International Psychology Research and Service Award seek to perpetuate.

The award is accompanied by a \$300 check, a certificate, conference registration for participation and presentation at the annual conference, and the next year's dues for ICP membership.

AWARD MANAGEMENT.

The Fukuhara Award for Excellence in International Research and Service is managed through the ICP, Inc. Finance Committee and a Committee of five members appointed by the President to oversee the procedures of selecting and presenting the award.

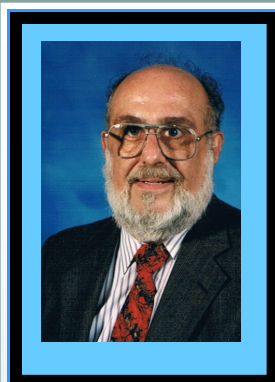
The Finance committee manages the investment of the Fukuhara Fund to assure sufficient monies are available in the operations account to cover all expenses of the award. A report is submitted to the President and Board annually.

The Fukuhara Award Committee publishes the call for candidates, who may be nominated by members and by self nomination in the fall and winter before the annual conference. The committee manages all aspects of communications, selection and presentation of the award and assures a time in the scientific program for the recipient's presentation. All committee members review nominees to determine the recipient on the basis of a five criteria, each criterion weighted 1-5 with 5 the maximum:

1. A resume that reports reviewed [juried] publications
2. Participation in international conferences and programs
3. Unique and outstanding research with international implications / applications
4. Leadership in international associations and organizations
5. Evidence of being an exemplar of ICP, Inc. values and professional ethics

MESSAGE FROM THE TREASURER

Dear Colleagues,

The 69th ICP Convention held in Washington, DC is a fading memory and ICP must continue to look to the future as plans are developing for IC/P 70th convention in Seville, Spain September 4 – 9, 2012.

In Washington I presented a gloomy picture of our financial condition stressing the importance of conserving our dwindling resources. I referred to the preliminary budget report for the 69th conference with my estimation that if nothing changed ICP would experience a loss of between \$6,000 and \$8,000 on the convention. The principle reason being a lack of attendance (40) and the cost of food/beverages and presentation rooms in D.C.. Just ICP audio-visual requirements were half ICP registration fees. However, many last minute contributions were made and some donated items made up the difference with accounts for about a third of expenses. While I applaud the generosity of those involved, ICP cannot continue existing on the wallets of our wealthier individuals and ICP closed with a very modest gain of \$250. That will serve as seed money for Seville.

Assistant Treasurer Scott Fraser and I are preparing the first call for 2012 dues which will be e-mailed the first week in October. Three reminders will then be e-mailed once a month in November, December, and January. For those individuals not having e-mail, their dues statement will be sent by postal delivery at the same time. However, due to costs they will only receive just that first notice. Remember, the Board decided two years ago to abolish life and permanent member categories and replace it with just two memberships: student (\$25.00) or full membership (dues based upon the country where you work, not your country of residence.) I encourage each of you to renew your membership as soon as possible so ICP can determine the budget for 2012. A late fee will be imposed after December 15, 2011.

I wish you good weather in the fall after a hot and humid summer in Florida.

MESSAGE FROM THE TREASURER—Gifts to 501(c) 3 organizations

Subj: Gifts to 501(c)3

Background: ICP operates as a IRS designated 501 (c)3 tax exempt organization which means ICP does not pay federal income on revenue earned. Such designation allows dues or registration at ICP conventions to be tax deductible for the membership. However, ICP has no guidelines for accepting contributions or donations.

IRS Guidelines: The IRS guidelines are contained in the 2010 Individual Tax Return Form 1040 Instructions, paragraph 615, lines 16 – 19.

"The following are deductible as charitable contributions in money or property (but not the value of your time or services) to domestic organizations operated exclusively for religious, charitable, scientific, literary, or educational purposes or the prevention of cruelty to children or animals; domestic fraternal organizations if the gifts are to be used exclusively for religious, charitable, scientific, etc., purposes; veterans' posts and organization; federal, state, or local governments if the gift is made exclusively for public purposes; qualified private organizations engaged in fostering natural beauty; or nonprofit cemetery and burial companies.

For the taxpayer seeking deductions:

Unreimbursed expenses incurred in performing services for a charitable or governmental organization may also be deductible. This includes the cost of special uniforms, auto, travel expenses, and other actual expenses in doing volunteer work for a qualified organization. A taxpayer who uses his auto in performing services for a charity can deduct either his actual out-of-pocket expenses for oil, gas, etc., or a flat 14 cents a mile. Add parking and tolls to the amount you claim under either method. But do not deduct an amount that were repaid to the taxpayer.

Travel expenses, such as for transportation, meals, and lodging, incurred when a taxpayer is away from home performing services for a charitable organization are deductible, provided that there is no significant ele-

ment of personal pleasure, recreation, or vacation in the travel. However, the fact that the taxpayer enjoys the service to the charitable organization, such as where a troop leader takes a youth group on a camping trip, will not cause the deduction to be denied."

Discussion: ICP should adapt a policy regarding gifts or donation.

Suggestion: ICP, when approached by a contributor contemplating a gift or donation, should request a specific purpose for that gift or donation, which could be either a gift or donation to the general fund or a specific project. When accepted, a letter acknowledging the gift or donation shall be written by the President, or at the Presidents' discretion, the Treasurer.

News from the United Nations

This report is in 2 parts. The first will deal with the first ICP UN meeting of the year and, the second will deal with the CoNGO board meeting held in New York.

ICP Representatives

The ICP representatives include the following people: Martin Butler, Eva Sandis, Norma Simon, Richard Velayo, Helen (Lena) Verdelli, Pete Walker and Tya Ramani, our young student member. Of course I am part of the team as the main representative.

We met on September 22, 2011, and reviewed our current United Nations activities. The group is active and holds various offices. Thus Martin Butler is co-chair of the fifth annual Psychology Day which will be held on April 19, 2012. Eva Sandis is chair of the Committee on Migration and past chair of the Family Committee. Norma Simon is recording secretary for the Committee on Ageing and serves on the Executive Committee on Mental Health and the Family. Richard Velayo is treasurer of the Committee on Ageing and serves on the Publicity Committee of the International Day of Older Persons. Lena Verdelli serves on the Executive Committee on the Family. Pete Walker is a newly elected member of the Committee on Sustainable Development, is active in the Committee on Ageing and serves on the Advisory Committee for Psychology Day. Tya Ramani was an intern for ICP last year and since all Committees are urged to have a young person serve on the Committee, she will continue this year in that capacity. Tya attends many committee meetings and records minutes in numerous instances. As past chair I continue on the Executive Committee on Ageing, treasurer of the Family Committee and corresponding secretary on the Committee on Mental Health. I am also on the Advisory Committee for Psychology Day, having been a past coordinator. I didn't list *all* of the Committees members be-

long to but they were discussed at the meeting.

All of the Psychologists at the United Nations are forming a coalition which will be helpful in terms of promoting psychology and presenting a united front where needed. Many people at the UN think psychologists only analyze people and through our activities we want to show the many different facets of our discipline. The ICP team discussed the need of evidence based psychology studies focusing on the items facing the United Nations.

Martin Butler briefly discussed the 21st annual commemoration of the UN International Day of Older Persons. The program will be held on October 6th at the UN. The title is "Launch of Madrid +10: The Growing Opportunities and Challenges of Global Ageing." Observance of the 2011 International Day of Older Persons will underscore the progress made in changing attitudes, policies and programmes for older persons during the first 10 year of the Madrid International Plan of Action on Ageing, and more importantly, will chart the road ahead.

At the meeting we also discussed honoring Margot Nadien and Al Weiss for their many years of service to the UN on behalf of ICP. One possibility is to have the celebration following Psychology Day. However, no definite plans are made at this time. We will also be selecting interns to work with the team.

CoNGO

I attended the CoNGO meeting on September 16, 2011. The meeting was held at the Salvation Army building in New York and was presided over by Cyril Ritchie, the current president. Cyril is based in Geneva, one of the three main centers for CoNGO, which also include New York and Vienna. President Ritchie mentioned that CoNGO is undergoing and organizational audit by KPMG, an auditing firm based in Geneva. Cyril Ritchie noted the difficulty in communicating the nature of CoNGO, since it is a world and not a Geneva one. However, the Swiss paid for the audit and will give CoNGO 300,000 swiss francs which is roughly equivalent to 300,000 dollars. Thus CoNGO should end 2011 clear of all debt and have some surplus.

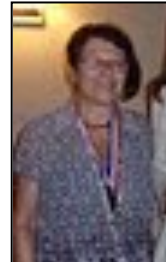
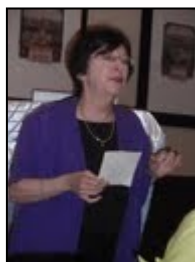

Report of 2010/11 Activities

UN representative in Geneva

As UN representative in Geneva I attended at the Millennium Summit meetings. World leaders committed themselves to the achievement of 8 Millennium Development Goals (MDGs) by 2015. Both rich and poor countries agreed to work towards the eradication of extreme poverty and hunger, the elimination of gender inequalities, the prevention and treatment of HIV/AIDS, protection of our environment, and the provision of education, healthcare and clean water. Since then the MDGs have had a catalytic effect on global development because of their simplicity, accessibility, and because progress against them is easily monitored. In UN Summit, September 2010 it was requested the Secretary-General to report annually on progress in the implementation of the Millennium Development Goals until 2015. Secretary-General Ban Ki-moon and Heads of State and Government, along with the private sector, foundations, international organizations, and civil society and research organizations, today kicked off a major concerted worldwide effort to accelerate progress on women's and children's health. In 2010 child mortality (MDG 4) has been reduced, but not quickly enough to reach the target. Maternal mortality (MDG 5) remains high in much of the developing world.

In Geneva, March 2011, Conference on Disarmament was held. The Conference on Disarmament (CD), confirmed in 1979 as the single multilateral disarmament negotiating forum of the international community, was a result of the first Special Session on Disarmament of the United Nations General Assembly held in 1978. The current Director-General of UNOG is the Secretary-General of the Conference on Disarmament as well as the Personal Representative of the UN Secretary-General to the CD.

Committee on the Elimination of Racial Discrimination was also held in Geneva, March 2011. The Committee on the Elimination of Racial Discrimination (CERD) is the body of independent experts that monitors implementation of the Convention on the Elimination of All Forms of Racial Discrimination by its State parties. All States parties are obliged to submit regular reports to the Committee on how the rights are being implemented. States must report initially one year after acceding to the Convention and then

every two years. The Committee examines each report and addresses its concerns and recommendations to the State party in the form of "concluding observations". In addition to the reporting procedure, the Convention establishes three other mechanisms through which the Committee performs its monitoring functions: the early-warning procedure, the examination of inter-state complaints and the examination of individual complaints.

Recently, the Health Assembly is held in Geneva. World Health Assembly is the decision-making body of WHO. It is attended by delegations from all WHO Member States and focuses on a specific health agenda prepared by the Executive Board. The main functions of the World Health Assembly are to determine the policies of the Organization, appoint the Director-General, supervise financial policies, and review and approve the proposed programme budget. I am updating information about the Geneva Human Rights Council. The Council decided to reinforce its technical cooperation with the Kyrgyz Republic; to proclaim 24 March as the International Day for the Right to the Truth; to accelerate efforts to eliminate all forms of violence against women and to address attacks on school children in Afghanistan. Four years after its creation, the Human Rights Council continues to dedicate itself to its overall objective to protect and promote all human rights and fundamental freedoms to make this world a better world for all and everywhere.

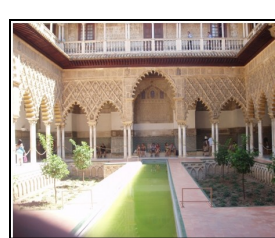

WHEN TROUBLE IN SCHOOL MASKS

SEXUAL ABUSE: A COMPARATIVE ILLUSTRATION OF THE DAVIDO-CHAD IN A CLINICAL CASE STUDY

Failure in school is a recurrent problem in schooling and its causes remain hypothetical. Teachers often invoke the student's immaturity as the root of his inability to adapt to the schoolhouse environment. Often this concerns children born during the fourth trimester of the school year, and are thus younger than their peers in their age group. These are described as slower, less well adapted, and more easily tired out. Teachers also question the student's intellectual capacity and ask themselves if the student is sufficiently capable to learn.

We use an innovative diagnostic technique, the CHaD, because this test follows step by step the train of thought of a child who will verbally and with pictures express his problems without an intermediary. The child understands well that he is the one at the center of the dialogue that unfolds between himself and the psychologist.

The clinical psychologist is thus foremost in a role of aid to the child, "at his bedside".

Connecting failure in school to mistreatment is a diagnostic that can come with heavy consequences. There is a positive effect for the child, as one can hope that the physical abuses will stop, that the child will be able to reconstruct himself and most of all that later, thanks to therapy, he will not repeat the behavior and will not cause anyone else to live through what he has lived through. However the description of sexual abuse, even if it is a duty, is not harmless and cannot be done without doubt reticence or fear.

That which the child's drawings reveal should be paid attention to, but drawings remain but drawings. Aside from diagnostics, the test will permit the formulation of a prognostic on the degree of the child's cognitive and affective degradations and thus permits one to attempt to adapt an adequate aid for the child's future.

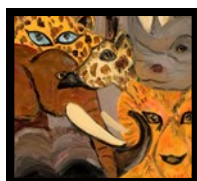

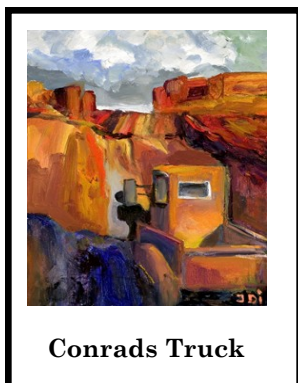

ICP 69th Annual Convention in DC 2011

Report from Chairperson of the Continuing Education Units

This year, Washington DC was selected for the location of our ICP 69th Annual Conference, where a wonderful group of professionals gathered to celebrate, share their research findings, meet, explore, and engage.

There were four workshops with continuing education units. We express our deep appreciation to Dr. Tara Pir, the Executive Director of the Institute for Multicultural Counseling & Education Services Inc. (IMCES) for assisting in the CEU granting process. Here are the 2011 CEU workshops:

Introduction to action learning and Team coaching (ALTC):

AL and ALTC are becoming increasingly popular in North America and are well established in other parts of the world (especially Asia) as a method for developing both leadership potential and organizations, particularly those that are contemplating or engaged in fundamental change initiatives. This workshop helped with experience in team building, team facilitation, and T-groups understand and appreciate how ALTC can enhance and complement their practices. A key goal of the workshop is to present and demonstrate the best principles and practices for effective AL initiatives. This workshop was organized by Arthur M. Freedman, MBA, Ph.D. co-authored by Michael Marquardt, Skipton Leonard, and Cori Hill (2009).

The workshop described the basic principles of ALTC – including the key components of AL, the basic ground rules and practices, how and why it works, and how ALTC compares with and complements other leadership and organization development and change theories and methods; and defined several possible roles that are critical for AL: as ALT members, problem presenters, coaches, and/or observers; a lively Q & A followed.

The second workshop was entitled **Behavior Modification Issues for People with Developmental Disabilities**. Some Strategies for Multi-Disciplinary Intervention was presented by Subhas Chandra, PhD, Associate Professor, School of Education, at the University of the South Pacific, in Suva, FIJI. Workshop objectives were to identify and evaluate the key issues faced by people with disabilities in the community; understand the nature of challenging behaviors and the role of behavior interventions for people with disabilities; Examine the role of personal values and operational policies in the implementation of behavior intervention strategies, develop proactive strategies to eliminate or reduce challenging behaviors for specific individuals; identify the main types of reactive strategies used to address challenging behaviors; and discuss the circumstances where reactive strategies are appropriate. A lively Q & A followed.

The third workshop was a **Forensic Session** organized and led by Betty Bishop and Julia Rose, who presented focusing on the following objectives: the APA guidelines for evaluations in child protection cases; to list 3 psychological tests often used with adults in these evaluations; to describe at least one ethical issue that often arises in these cases and discuss ways to resolve it.

The fourth workshop addressed **Spirituality, Creativity, and Intuition**. This workshop analyzed and discussed correlations among the creative personality, intuition, and spirituality, and how these influence and impact upon individuals and their behavior. Two very well-matched groups were administered the Creative Personality Inventory (CPI), the Intuition Inventory (II) and the Criterion Group of people formally recognized for their accomplishments scored significantly higher on both the CPI overall and its subscales and the II and its subscales than did the Matched Group without formal recognition for accom-

plishments. When another group of individuals---teachers and counselors--- was administered the CPI and the Inventory on Spirituality (IS), creativity and spirituality were found to be significantly related.

In yet another study, social workers rated themselves as highly spiritual and communal (family and community oriented) on the life Choices Inventory. The following workshop objectives were met: to learn about what creativity, the creative personality, intuition, and spirituality are, how they influence and impact people, and how they are important to those whom we see in academic and private practice settings; to help elicit correlations amongst creative personality, intuition, and spirituality; to emphasize the importance of spirituality as a vital part of the healthy functioning person; to explore whether the creative personality and intuition emerge from the springboard of spirituality, and to define the 7-step Biopsychosocial and Eco-Spiritual Model founded by Dr. Kalayjian for improving creativity, deepening insight and intuition, and practicing different models of spirituality.

Drs. Kalayjian and Rayburn were the presenters. A lively discussion followed which concluded in a formulation of a new Interest Group on Creativity, Intuition on Spirituality (CIS). Co-chairs of this Working Group are: Drs. Caroline Rayburn (DC, USA) and Ani Kalayjian (NY, USA). Members of the Interest Group are: Drs. Subhas Chandra (Fiji), Susan Patton (Italy), Luz E. Rivera (AZ, USA), Anna Laure Communian (Italy), and Donna Goetz (MA, USA).

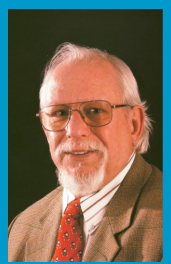
