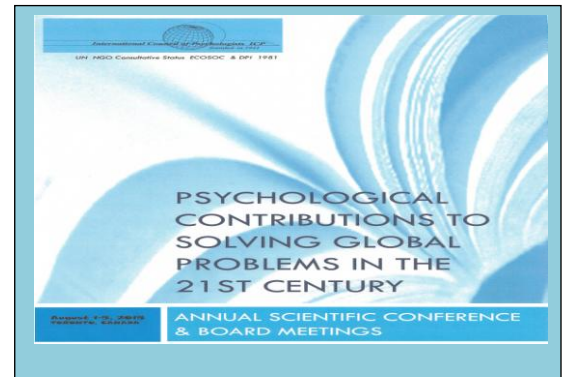

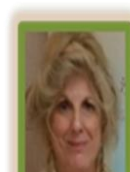
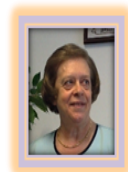

**Measuring Goal 16 on peaceful and inclusive societies in the SDGs process**

In September 2015 world leaders will meet at the UN to adopt the Sustainable Development Goals (SDGs), forming the international development framework that will replace the current Millennium Development Goals. The seventeen proposed goals and associated targets are planned to run until 2030. Amongst them, Goal 16 focuses on peaceful and inclusive societies, access to justice, and accountable institutions. The inclusion of Goal 16 in the reflects the growing acceptance that issues related to peace, security, and good governance should play a role in the post-2015 development framework. This progress of a global agenda on peace and development has been possible thanks to the work of several processes, including the Geneva Declaration on Armed Violence and Development (GD), which calls for measurable reductions in the burden of armed violence that humankind faces. . Since the beginning of the initiative in 2006, the Geneva Declaration has always received a strong support from the Small Arms Survey on its 'measurability pillar'. In the SDGs negotiations framework, measuring armed violence is central for the development of clear targets and indicators. The measurability of these targets will be a crucial and guiding factor, and will support determining how well states fulfill their commitments. Since the beginning of 2013, the Secretariat of the Geneva Declaration participated in several international events that support peace and human security in the post-2015 development agenda. These include thematic consultations on violence and citizen security in Panama (February 2013) and Finland (March 2013), and expert meetings in Glen Cove (June 2013), Vienna (June 2013) and New York (September 2013). Furthermore, the Secretariat highlighted the issue in various fora and events including at the International Security Forum (ISF, April 2013), at which the GD made a presentation on “Security: The Next Millennium Development Goal?”; or at a side-event on “Peace, development and human security: toward new Millennium Development Goals?”. co-organized in Geneva on 23 May 2013 with the Permanent Missions of Finland, Panama, and Switzerland, in cooperation with the United Nations Development Programme (UNDP), the Quaker United Nations Office (QUNO). Throughout 2014, the Geneva Declaration Secretariat jointly organized a series of five Regional Review Conferences (RRCs) in Guatemala, Switzerland, the Philippines, Morocco, and Kenya. The conferences were co-hosted by the host country, in partnership with the Government of with Switzerland and United Nations Development Programme (UNDP). The objectives were to not only review the implementation process of the GD in different regional contexts and strengthen the engagement of the signatory states to the GD, but to also gather support for the meaningful integration of armed violence reduction in national and international development processes, including the post-

2015 development agenda. The work undertaken by the Geneva Declaration Secretariat includes its major publication, the *Global Burden of Armed Violence reports* (2008, 2011, and forthcoming 2015) which takes an integrated approach to the complex and volatile dynamics of lethal violence around the world. The *Global Burden of Armed Violence reports* use 'violent deaths' as the main indicator for measuring and monitoring the scope and impact of armed violence globally, and refine a methodology for its collection and analysis. On measuring violent deaths and illicit arms flows for Goal 16, the Small Arms Survey, with the support of the Geneva Declaration Secretariat, has published the following Research Notes: -Luigi De Martino and David Atwood. 2015. *Reducing Illicit Arms Flows and the New Development Agenda*. Research Note No. 50, Armed Violence. - Anna Alvazzi del Frate and Luigi De Martino. 2015. *Every Body Counts: Measuring Violent Deaths*. Research Note No. 49, Armed Violence.

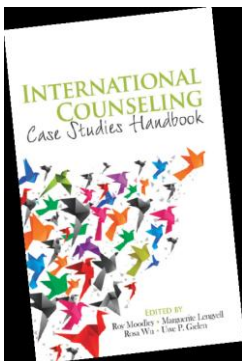

**Introduction:** The members of IICCP include two full-time

faculty in the psychology department, a professor-emeritus, four student assistants, and one intern. The student assistants are Amy Chen, Olakunle Davies (Fall 2014), Laudia Joseph, Huang Zhu, while Jennifer Ho, M.S. (doctoral student, Yeshiva University) served as an intern during the Fall 2014 semester.

Furthermore, during the Fall 2014 semester, Tahereh Ziaian, Ph.D. (University of South Australia) served as a Visiting Scholar at the institute. She, Dr. Gielen, and several other international scholars have been working on a research proposal focusing on a psychosocial investigation of young Chinese residing in five countries.

During the academic year of 2014-2015, IICCP continued to serve as a major national and international center for international and cross-cultural psychology. To fulfill its mission, IICCP and

its members sponsored a series of important events at SFC, supported student involvement in

*Unifying Psychology in the Next Generation  
through Collaboration and Contextualization.D.,*  
Professor Emerita of Human Development,  
University of Maryland, College Park

#### Educational Objectives:

1. To raise the awareness among attendees of what is often an artificial separation between divisions in APA;
2. To inform attendees how enhanced collaboration as well as seeing research in its context can contribute to unity across psychology;
3. To alert early career scholars in particular to their potential role in this process.

Judith Torney-Purta, Ph ward is expected to  
“deliver an address on a body of work that has the  
potential to be extrapolated to have unifying power  
within the discipline as a whole.” My address will  
have two parts. One will trace over the last fifty  
years my growing awareness of the importance of  
unifying ideas in psychology (especially in applied  
developmental, educational, social and  
organizational psychology).

The second part of the speech will present some of  
my professional activities and research illustrating  
two themes, which I believe have unifying power in  
the discipline. One is the process of collaboration. I  
will focus on international collaboration, but will  
also discuss inter-disciplinary collaboration. I will  
then consider contextualization -- how the context  
of the neighborhood, the family, and the school  
(along with the historical and cultural context) --  
shape both human development and research in

psychology. I have constructed a developmental  
niche model for adolescent's development in the  
political, civic and social realm that takes account  
of these factors. I will present my studies based on  
that model for contextualizing psychological  
research.

**The International Observatory for Human Right to Peace**

The [above named] civil society organizations remind that the United Nations were established 70 years ago with the firmly purpose of maintaining international peace and security and strengthening universal peace(1), to save succeeding generations from the scourge of war(2). Consequently, the General Assembly recognized in 1978 the immanent right of every nation and every individual to live in peace(3), and in 1984 the sacred right of all peoples to peace(4).

It is now to the international community to recognise and develop the human right to peace, in

light of the current developments of the international human rights law(5), as well as the work undertaken by this Council in favour of the human right to peace since 2008, at the request of civil society.

In **conclusion**, the [above named] civil society organizations request the Council:

1. To extend the mandate of the Working Group on the Right to Peace.

2. To invite the Working Group to initiate a real negotiation of the future Declaration of the United Nations on the Human Right to Peace, taking into account its essential elements, as developed both by the Advisory Committee Declaration on the Right to Peace (2012) and civil society in the Santiago Declaration on the Right to Peace (2010).

Ultimately, we believe that the future United Nations Declaration on the Human Right to Peace should require a normative development that would constitute a clear departure from political declarations adopted in the past. For this reason, it must proclaim with no ambiguity that every individual and all peoples are right-holders of the human right to peace. This right must be spell out with the substantive contents claimed by international civil society, thus being a significant step forward in the development of international human rights law, which is the basis to achieve freedom, justice and peace in the world. 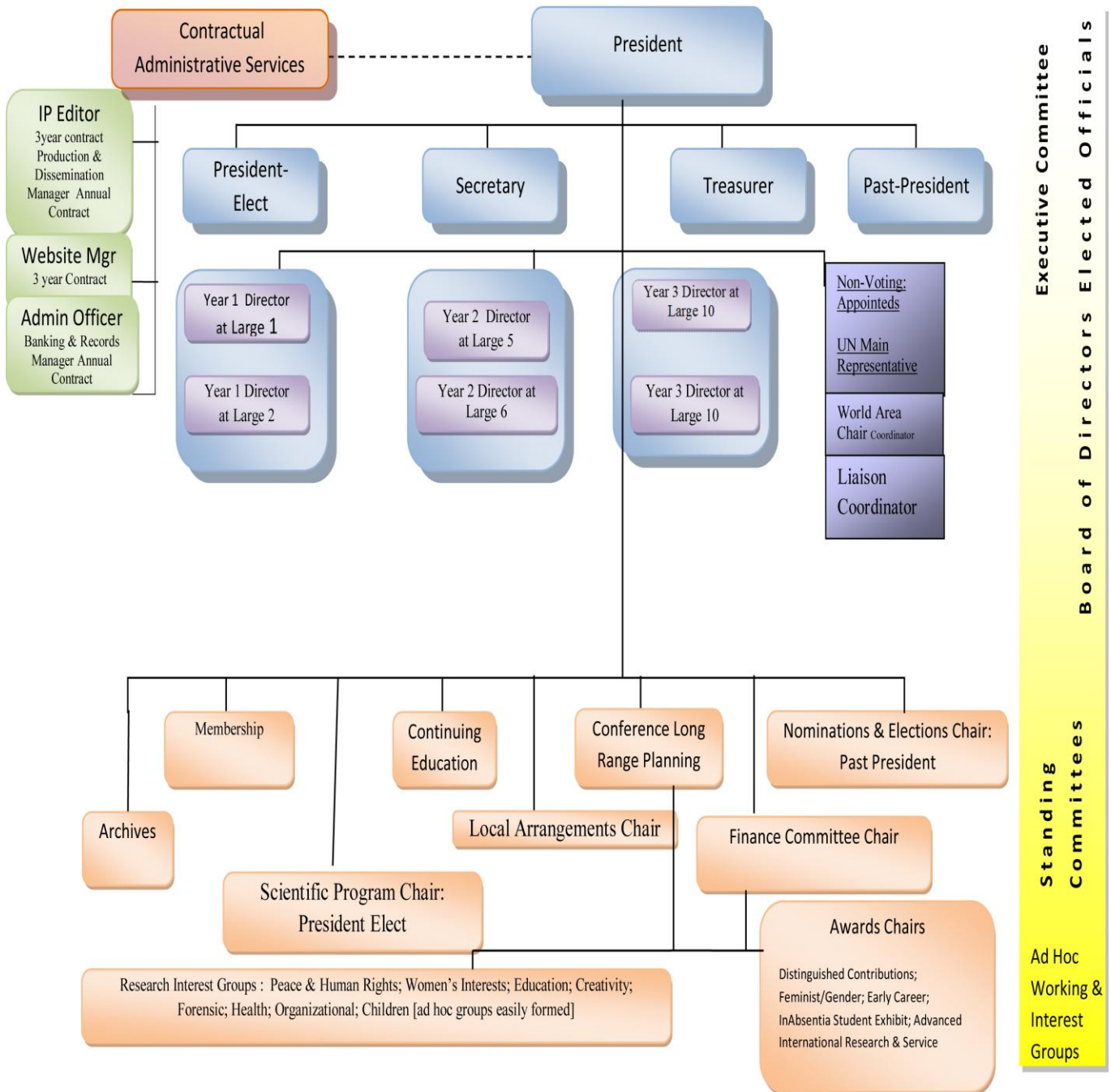
