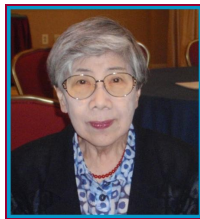

The workshop will be beneficial especially for those early career scholars who have no English speaking background.

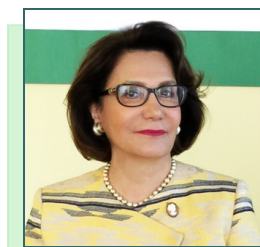

Whole Health Includes Mental Health

May is National Mental Health Awareness Month in California, USA. The Institute for Multicultural Counseling and Education Services, Inc. (IMCES), the community clinic I founded and directed since 1989 has taken a

leading role in promoting health and wellness through reducing stigma associated with mental illness. IMCES made a lifelong commitment to reducing disparity in many domains in our community. This includes facilitating equal opportunities for qualified candidates to access high standard clinical training programs. It also includes providing access for individuals from diverse vulnerable populations to health/mental health services.

We are in the heart of a multi-ethnic multi-cultural community, annually serving thousands with their mental health needs. We consider health and mental health a human right of all and practice the principle of inclusion. IMCES is truly providing a lifeline for individuals with mental health challenges.

The reality indicates that half of people over the course of their lifetime will deal with some type of mental health challenge. However, it is often dismissed due to the general notion of health as only physical health. An important part of mental health awareness is the recognition that mental health is a part of whole health.

I provide a weekly Cultural Diversity Training which focuses on many forms of the following:

- ◆ Mental Health movement
- ◆ Each Mind Matters
- ◆ Providing support and treatment
- ◆ Replacing fear with hope
- ◆ Living Stigma Free
- ◆ Directing and facilitating change

Our high standard doctoral clinical training provides leadership and advocacy opportunities for our new and emerging professionals. This year, our doctoral interns, who have IMCES and ICP dual membership, are conducting activities including workshops and public education seminars on many topics related to emotional resiliency and wellness. I have also initiated international cross-cultural research on cultural humility and stigma reduction. Our doctoral interns are participating in the research and advocacy projects to promote health and mental health. We are also spreading the message through social media.

We have raised awareness by promoting role models in our community, such as showing the documentary, "A New State of Mind: Ending the Stigma of Mental Illness." This film, narrated by actress Glen Close, focuses on a

few of the millions who refuse to stay silent while untreated mental illness takes an unnecessary toll on their families and communities.

These efforts have been recognized, including with the first Community Champion award for "Achievement in supporting and promoting underserved, unserved, oppressed or marginalized peoples" presented to me at the International Together Against Stigma Conference.

A quorum was in attendance for the motions to approve the minutes of the 2015 incoming board meeting and the annual budget. Minutes of the virtual meeting are still being finalized and will be distributed to all of the board members when completed.

Regarding the convention registrations, we've hit an administrative snag with the dual registration through the Congress and we need to know from you who is planning to attend ICP, Inc.'s 74th Annual Board Meeting and Convention being held in Yokokama, Japan, July 22-25, 2016. I have 6 names and know there are many more, but you'll need to email me with that information, so that I know. We need to order refreshments and food, prepare name tags, goodie bags, program books and all of those

I'll need to know if you are attending both conventions, what you'd like on your name tag, and if you have any dietary restrictions. I am currently working on developing the operating budget for the incoming board of directors meeting. As of May 28, 2016, the account balances are as follows:

- ◆ Operations Account: \$13,306.80, with June APs for contracts of \$1,750.00; one new member dues check on hand for \$50.00
- ◆ Convention Account: \$3527.42, with no pending expenditures
- ◆ Foundation Account: \$59,347.86, with 2016 Fukuhara Award planned reimbursement of \$300.00
- ◆ PayPal Account: \$2,159.80 of which \$930.00 will be transferred into the convention account for registrations; the balance are operations funds. All but \$159 will be transferred into the operations account in June.

Membership continues to be a main focus of the organization and the paid in full memberships of both students and professional members now stands at 80.

Please remember that membership renewals paid now must include the \$15 late fee which is activated February 1 of each year. In the September IP you will see the first call for 2017 dues. It serves your fellow members and the organization to pay your dues on time.

ICP at the United Nations

ICP has been an active participant of the NGO Committee on the Family.

In this report I will give you an idea some of the programs that both the ICP representatives and interns attended over the past two years.

In November of 2014, the topic was “The UN, The Family, and Sustainable Development Goals (SDGs)”. **Renata Kaczmarska**, a social affairs officer with the focal point on the family, spoke about the sustainable development goals. She stated that although the family was not specifically mentioned in the goals, it could make an impact in achieving the goals. The second speaker was **Dr. Josephine Tan**, who spoke about the psychological trauma among Canadian aboriginal peoples and its impact on the family. Doctor Tan is a clinical psychology faculty member at Lakehead University in the city of Thunder Bay in Ontario Canada. She is also a member of the ICP and serves as the awards coordinator.

Doctors Rashmi Jaipal and Ayorkor Gaba spoke about “The Effects of Globalization and Trauma on Families in Developing Countries (India and Nigeria)” in the January 2015 program. Doctor Jaipal is a Professor Emerita of Psychology at Bloomfield College, New Jersey, and a Representative of the American Psychological Association at the UN since 2013. She has a PhD in clinical and cross cultural psychology. Doctor Jaipal has done extensive research on Indian indigenous traditions, internationalizing the psychology curriculum, and she currently is doing research on the psychological aspects of sustainable development. The second speaker, Doctor Ayorkor Gaba is a Nigerian-born Clinical Psychologist, American Psychological Association Rep to the United Nations, and Senior Project Director at the University of Massachusetts Medical School Department of Psychiatry. She spoke about the impact of trauma on family development and well-being in northern Nigeria.

The topic of the February 2015 meeting was “Changing Families, Changing Societies: How Women, Aging, and Cultural Diversity are transforming our World”. **Doctor Bahira Sherif Trask**, a Professor and Associate Chair of Human Development and Family

Studies at the University of Delaware and a Policy Scientist in the Center for Community Research and Service, spoke about changing families and changing societies, and how women, aging and cultural diversity are transforming the world.

“Engaging and Supporting Families So Their Children Thrive” was the topic of the October 2015 program. **Doctors Claudia Williams and Parthener Olivia Pinder** presented their program currently being implemented in the SE Regional Health Authority Family Clinics in St. Thomas Parish, Jamaica. The third speaker, **Allen Shedlin**, Reel Fathers founder and president, spoke about the role that fathers play in their children’s success.

The meeting held in January 2016 focused on the topic of “Family Solutions to African Traditional Cultural Practices Harmful to Women: Exploring Men’s Role in the Eradication Process”. **Mame Kani Diop**, Doctoral Research Assistant at Montclair State University in the Department of Family and Child Studies was the guest speaker of the program. Doctor Diop’s specialized area of study has been on female genital mutilation. She spoke about family solutions to African traditional and cultural harmful practices to women and how men as well as families can play a role in the eradication process.

In February 2016 the meeting’s topic was “Parenting: Basic and Complex Contemporary Issues”. **Doctor Barbara Mowder**, the Director of Graduate Psychology Programs at Pace university, and the Parent-Child Institute was the guest speaker of the program. She spoke about various parenting styles and the importance of different styles and their effects on the family structure.

“Fostering World leadership in Young Women-Starting with the Role of the Mother” was the topic of the meeting held on March 2016 during the UN Commission on the Status of Women. A distinguished slate of panelists discussed how different sectors of society can support the role of mothers and help young girls achieve their full potential. **Doctors Neill F. Marriott, Abaynesh Asrat, Leslie Goldman, and Weronika Janczuk** were the Panel speakers of the program.

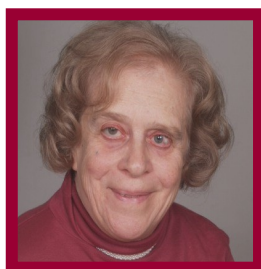
On April 2016, the ICP and APA interns jointly put on a program on “Different Causes of Family Trauma: Finding Resiliency on a Global Scale”. The ICP interns will prepare a report on their part of their presentation for a future issue of the IP.

May 15, 2016 was the UN International Day of the Family and **Renata Kaczmarska**, UN focal point on the family, presented an expert group meeting on raising awareness for family policy issues for development. The Family Committee held a meeting on May 19th on “Grandparents in the Family: Key for Intergenerational Solidarity”. **Doctor Kevin Brabazon**, Professor at New York University, spoke about how older people use both

hemispheres of the brain for tasks while younger people use primarily one hemisphere and how this can provide evidence to support the idea that older people may activate rationale and emotional parts of the brain simultaneously. The second speaker **Nandi** told a story of her grandfather in South Africa. Finally, the third speaker **Ed Ryan**, Senior Legislative Advocate for AARP in Pennsylvania, mentioned that AARP reports 7 million grandparent-headed homes in the US. He furthermore spoke about the positive effects of grandchildren on grandparents.

The Year at the Geneva United Nations

As UN Representative in Geneva, past year I have working to collect information and data about the post-2015 Millennium Development Goals (MDG). The aim of the Policy Dialogue of the Sustainable Development Goals (SDG) is to evaluate the progress made in the definition of SDGs and to discuss the difficulties and opportunities. Sustainable development demands a data revolution to improve the availability, quality, timeliness and disaggregation of data to support the implementation of the new development agenda at all levels. About putting ***People First in Public-Private Partnerships (PPPs) for Sustainable Development***, David Nabarro, Special Adviser on the 2030 Agenda for Sustainable Development, defined the 2030 Agenda as “a political manifesto for the future of the world”. He identified a renewed interest in “multi-stakeholder partnerships” and called for the elaboration of new guidelines: “As these multi-stakeholder arrangements are more and more coming into play, there is an absolute need for the establishment of sets of principles that governments can use to ensure that as they are implemented the full range of issues in the 2030. This includes transparency and accountability. They also tend to include the involvement of beneficiaries in decision making and clear governance arrangements”. This new, all-inclusive, ‘people first’ model emphasizes transparency, accountability and multi-stakeholder involvement. Furthermore, there was full agreement at the Forum that this vision of a PPP model which improves people’s live, alleviates poverty and promotes a better planet. It was indeed how the PPP model should be developed and mainstreamed into development financing in

the future. Not all the messages however were positive about use of PPPs for financing public infrastructure. One NGO argued that PPPs were not the most appropriate procurement mechanism to deliver the SDGs and several others pointed out that, for various reasons, many past PPP projects had failed to deliver expected benefits and that bad examples should be mentioned along with the good examples.

The 17th Edition of the ***“Geneva International Model United Nations Annual Conference 2016”*** organized by the Geneva International Model United Nations (GIMUN) takes place. The member States welcomed the initiative of the Secretary-General and stressed that it is essential to address the threat posed by violent extremism as and when conducive to terrorism. This recognized that violent extremism cannot and should not be associated with any religion, nationality, civilization or ethnic group. The United Nations is well suited to support Member States in adopting the comprehensive approach that is needed to proactively address the drivers of violent extremism. UN agencies and other international organizations in Geneva work at the crossroads of peace, rights and wellbeing and are at the core of implementing the 2030 Agenda for Sustainable Development. Providing sustainable development opportunities, reducing inequalities, safeguarding human rights and providing a hub for mediation and peace negotiations, help to create a context and change realities on the ground that are better suited to resist extremism. Geneva-based agencies and actors are well placed to address the complexity of constellations that nourish violent extremism. The ***Geneva Conference on Preventing Violent Extremism (April 2016)*** aimed to provide an opportunity for the international community to share experiences and good practices in addressing the drivers of violent extremism and to build support for the Plan of Action. To Prevent Violent Extremism provides an important framework to address the issue at hand. The Plan has been welcomed by the General Assembly, showing the positive commitment of the international community to unite and act against this threat. During past weeks at the Palais des Nations, many important issues which top the agenda of several United Nations entities and organs, from conflicts to terrorism, from climate migrants to privacy issues, from health to disarmament, from empowerment of women to human rights have been discussed. An example of the issue that was very high on the agenda of the international community today, namely the issue of refugees and migrants. The war in Syria has caused unacceptable human suffering, serious consequences for neighboring countries and ramifications far beyond its borders, primarily in Europe. International migrants who reside outside their country of birth or citizenship rose from some 170 million in 2000 to nearly 250 million in 2015 – an increase of 41 per cent. More than 60 million

people are currently forcibly displaced. This is the highest number since the end of the Second World War. This includes 20 million refugees, which means that 8 out of every 100 international migrants are now refugees. These policies need to take into account a variety of issues, such as the human rights of migrants and refugees, the root causes of migration, contribution of migrants to societies, amongst others. There is also a pressing need to increase humanitarian financing, and a number of discussions are scheduled for the agenda of the international community this year.

HOAX ALERT REGARDING A UNITED NATIONS MEETING

We have been alerted to a hoax by several of our members. A meeting allegedly scheduled for April 26-29, 2016, in London, by the United Nations Department for Sustainable Development to establish an inclusive and transparent intergovernmental process on SDGs was apparently an elaborate hoax that cost members "hotel" funds and passport information. This department is a valid United Nations entity, but the meeting was a hoax. For more information, please visit the [United Nations Fraud Alert website](#). 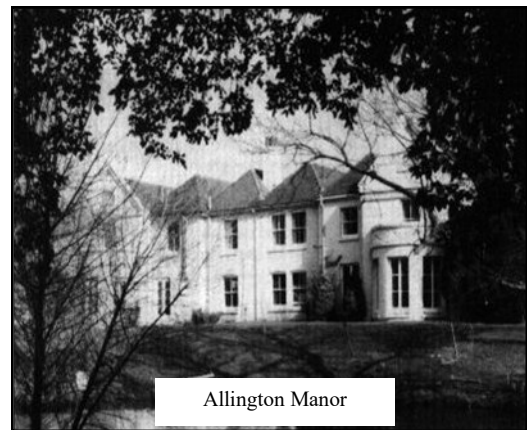
AVE ATQUE VALE

PRESIDENT LUDWIG F. LOWENSTEIN 1930-2016



Dr Lowenstein obtained his M.A. and Doctorate in Psychology and Education at London University, and is one of Britain's most quoted authorities on psychology in Education. His background includes work on mental hospitals, child guidance clinics and residential centres for maladjusted adolescents in New York City. He served as a teacher, a welfare officer, and, in Australia, as a probation officer. Over the years he has held such appointments as: Director of Assessment and Guidance for maladjusted boys with learning difficulties, London and Winchester;

Chief Examiner in Education Psychology, College of Preceptors, London; former educational psychologist in Essex and London; Visiting Lecturer to the Universities of London, Southampton, Maryland (U.S.A.), and Visiting Professor to the University of Khartoum (Sudan), as well as to many U.K. Colleges of Technology and teacher training colleges. His appointments have included a directorship of the International Council of Psychologists and the Chair of the Hampshire Association for Gifted Children. He has also written widely on the subject of educational psychology and forensic psychology, and as its first Editor-in-Chief, helped found the journal *School Psychology International*.

LETTER FROM BYLAWS CHAIR
Dr. Robert Silverberg

At the Board meeting in Toronto, I agreed to have a look at the current Bylaws plus the Board Rules and AP&P. I viewed that as a chance to review and if possible revise these in order to bring up to date and make more relevant.

I have had a good look at these documents now. I am dismayed by the enormity of the task. In some respects the exact wording of the current bylaws exists in several forms, as do the other two documents. It is also unclear if many of the changes in the past few years have ever been adopted in accordance with Bylaws, and consistent with requirements in the Certificate of Incorporation.

Nevertheless, I started with a good look at the Bylaws, as the form and content of the Board rules, and the AP&P, depends on this. I've drafted 3 separate versions of possible replacement Bylaws but on reflection I am not prepared to put any of these versions forward, even as a draft or as working papers. Instead, I have reached several conclusions and have corresponding recommendations. These issues in my view need to be conclusively addressed before any revisions can be legitimately undertaken.

Name of the Organisation:

In the event that ICP plans to change its name then this would require a revision of the certificate of incorporation before any bylaws could be redrawn. I am personally in favour of making **no** change to the name of the "International Council of Psychologists" in either the bylaws or the Certificate of Incorporation. These are legal issues as well as professional, and would require that the Board engage a lawyer to offer an independent opinion of the costs, effects, and advantages/disadvantages to the various legal statuses of ICP.

Scope of Membership:

Similarly no work can be done on the bylaws until the scope of membership is decided upon. Personally, and keeping in mind that I am not a psychologist but a physician, I believe that a flat membership structure dilutes the value of ICP membership and reduces the overall brand value of ICP. I am strongly in favour of returning to the traditional membership structure of "full membership" (and therefore voting membership) being restricted to Psychologists only. Non-Psychologists could be offered another form of membership through the reestablishment of additional membership classes. This seems to me to best reflect the stated goals of the organization. People like myself who are registered or licensed in recognized scientific professions with an interest professionally in psychology (Medical Doctors, Social workers, occupational therapists, teachers, podiatrists, journalists etc.) more accurately belong in a non-voting

"Professional Affiliate membership category. Students could be in a "Students" category. Other non-professionals interested in psychological matters could be "Associate Members". None of these other than Psychologists should be eligible to serve as voting members, or as voting members of the Board of Directors. I believe that opening the membership more broadly and generally, although theoretically attractive as a kind of inducement for people outside the Psychological profession to sign up (and possible pay membership dues), dilutes the value of being a psychologist member. Opening full membership to non psychologists is very likely to result in the effective management of ICP to end up in the control of non-psychologists. Then, the ICP as an organisation could lose its special status and become just one of very many general health or mental health organizations. I would not support that. I think the protocols followed by the American Psychological Association and in fact the Australian Psychological Society as to membership categories are good templates for moving forward.

Board membership:

I think the Board needs to be broadly constituted with 9 members. 3 per year elected in rotation. Fewer Board members inevitably make factional control too easy and should be avoided.

Committee Structure:

The committee structure is overly complex. Most committees do not meet and in fact have no functional chairs at present. I would prefer functional officers who constitute a more strongly empowered Executive Committee, each of whom supervises or chairs one or more Committees. Right now we cannot even fill our officer roles, much less committee chairs or members. Of great importance is a revitalization of the Area Chair structure, as globalisation will produce increasingly regional affiliation opportunities for ICP and its members. The World Area Chair role is best structured as a semi-autonomous position, filled by nomination to the Board and election by the Board rather than by appointment, and constituted as a voting (co-opted) member of the Board of Directors.

Similarly, the United Nations delegation is probably the most essential function of ICP at present, and for the future. The Head of the ICP UN delegation could be given significantly more autonomy and responsibility and also made a co-opted voting Board member. The World Area Chair and UN Delegation Chair are so critical that they both require extensive ICP membership experience in a variety of roles, over a long period of membership time. They would be best construed as long-term positions, say seven or ten years, automatically renewable unless decided otherwise by the Board, answerable to the Board rather than the Officers of the day, by report.

Dues Structure:

We need to restructure our dues not only as A B C countries as is traditional, but also as to membership category and seniority. For example, early career members and students could pay little or even nothing. 3to7 years at a higher level and over 7 years full rates. In the past we have made it too cumbersome to join the organisation. As long as anyone could be an associate member the joining process at that level could be made very simple. Full members i.e. psychologists would have to certify that they are in fact degreed and qualified Psychologists in their home countries or regions. It has been very difficult to get independent verification of this in the past, so perhaps we could accept personal declarations as a way of streamlining the membership process.

Timing Of Meetings And Conventions:

I think that it is best to require an annual membership meeting. This would of necessity have a physical location, but to avoid the problem of attendance, we could allow duly executed proxies, or online voting for questions to be put to the membership. Board meetings can be held in a fashion which from time to time is practical. Again, the use of legitimate proxies can compensate for the ongoing attendance difficulties. As to Conventions, I suggest that regional conventions may over time supplement and even supplant the concept of a single major Convention.

These are some of the matters which need to be resolved before the Bylaws, AP&P, and Board rules can be revised. Over the years we have hastened into revisions based on the difficulties and problems of the day. If we are less prescriptive and specific, and general enough in the Bylaws (even a little anarchic!) we may very well gain the flexibility that in the past has been difficult to achieve.

I suggest that a 5-year timeline be set up for thorough revision of the Bylaws, AP&P, and Board Rules, once these issues are resolved in a way that is satisfactory to the Membership; that a new Committee chaired by a Psychologist with a working party structure could address the many issues piecemeal, with deliberation, and hopefully a better outlook based on the ongoing, long term viability of the organisation.

GUIDELINES FOR HOSTING AN INTERNATIONAL COUNCIL OF PSYCHOLOGISTS, INC. ANNUAL CONFERENCE AND BOARD MEETING

The International Council of Psychology, Inc holds an annual scientific program and Board meeting each year in accord with the policy of freedom of movement of scientists. The conference host (local arrangements committee) must be a member of ICP, Inc. To establish the feasibility of submitting an application, a potential applicant might begin with an overview of some logistical issues for proposing a Congress venue:

- ♦ Is there a conference venue to host at least 80 participants? Are there sufficient hotel rooms close to the conference venue?
- ♦ Is there a scientific community to develop or sponsor the program?

Proximity in time and site to other major professional congresses. ICP operates in alliance with the International Association of Applied Psychology [IAAP, quadrennial congresses], the International Union of Psychological Science [IUPsyS, quadrennial congresses that meet in between the IAAP cycles]; the American Psychological Association or the Canadian Psychological Association; with options for meeting near allied professional association on intervening years.

Proximity in time and site to other major professional congresses. ICP operates in alliance with the International Association of Applied Psychology [IAAP, quadrennial congresses], the International Union of Psychological Science [IUPsyS, quadrennial congresses that meet in between the IAAP cycles]; the American Psychological Association or the Canadian Psychological Association; with options for meeting near allied professional association on intervening years.

Geographical Rotation among continents and countries attempts to guarantee broad geographical coverage, proximity to other major professional conferences, or in regions where psychologists may not have presented a scientific program previously.

The scientific community in the conference country is especially invited to participate in the scientific program.

Communication: There is a requirement for intensive and frequent communication between the Board President, Scientific Program Chair, Local Arrangements

Chair, Workshops Chair, InAbsentia Student Posters Chair, and Awards Chairs.

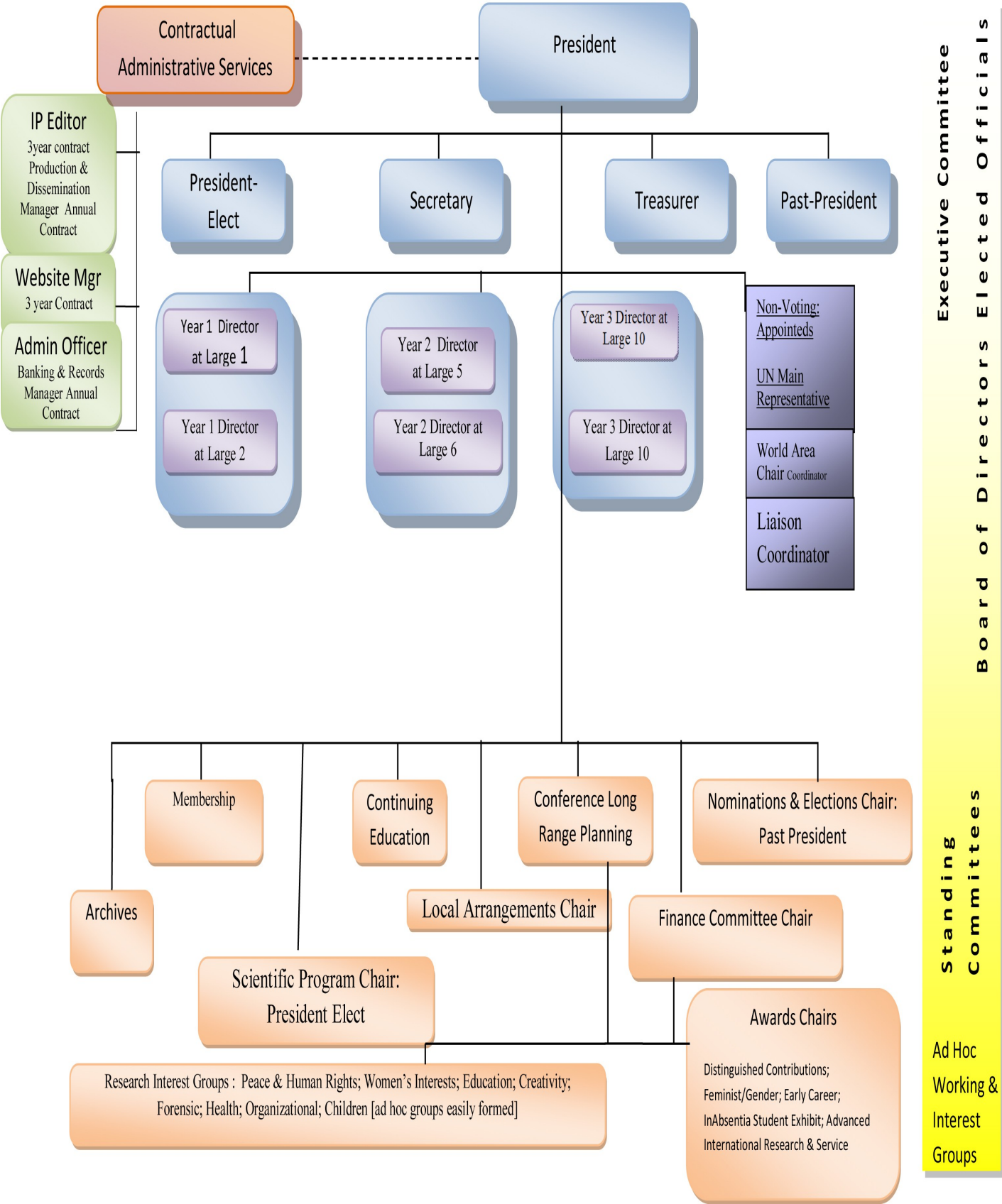
Costs for participating in the Congress are another factor. The Board will expect that the registration fee will be reasonable, that there is a range of good hotel rates (including inexpensive ones) and that travel costs can be kept as low as possible. Despite efforts to keep costs low, travel is expensive for **young psychologists**, and for psychologists from the **developing world and transition countries**. It is therefore important to provide a plan that will guarantee special fees, housing, and support for those colleagues.

A balanced budget needs to be provided in outline. It is important to show realistically how the income (registration fees and other) will cover your costs. It may be helpful to consult the preceding organizers of conferences in drafting the budget. The budget is reviewed by the President and the Treasurer, who can offer advice.
