I am writing to express my enthusiastic interest in the internship at the International Council of Psychologists (ICP). As a Master's student in Clinical Psychology at Teachers College, Columbia University, I am deeply committed to leveraging psychology to address global challenges, particularly in promoting mental health, reconciliation, and well-being in conflict-stricken and underserved communities. This internship aligns perfectly with my aspirations to contribute to psychology's role in advancing the United Nations' Sustainable Development Goals (SDGs), particularly SDG 3 (Good Health and Well-Being) and SDG 16 (Peace, Justice, and Strong Institutions).

My primary interest lies in international psychology, which has been my life's calling. Growing up in the Palestine-Israel region, I was immersed in a context of conflict that instilled in me a lifelong drive to understand and facilitate processes of peace as well as psychological healing and well-being, which I see as both a human right and a crucial part of peacebuilding. This personal calling has guided my academic, professional, personal, and activist pursuits. My work in peace and solidarity movements has centered on creating spaces for dialogue and connection between individuals from historically divided communities. These experiences taught me the transformative power of shared understanding and collective action in mitigating psychological distress and fostering hope. Through these movements, I organized communal events where Palestinian and Jewish families came together to share meals, engage in storytelling, and break down barriers of prejudice and segregation—work that underscores the importance of integrating mental health frameworks into peacebuilding efforts.

Academically, I study clinical psychology at Columbia University, and my research has focused on culturally sensitive interventions and the intersection of transformative mental health treatments and social justice. I have gained significant experience in psychology research, including work in social psychology at Stanford University at the Dweck-Walton lab, where I contributed to projects addressing systemic inequalities, and in psychoelic-assisted therapy for veterans at Johns Hopkins University and Ohio State University. These roles deepened my understanding of innovative therapies and their potential for transformative healing. I have also worked on qualitative and quantitative research exploring trauma and resilience, which aligns with ICP's commitment to evidence-based approaches. My time studying at the University for Peace, founded by the UN, further solidified my commitment to education, conflict resolution, and peacebuilding. Additionally, I am currently beginning to work at the Global Mental Health lab under the guidance of Dr. Helen Verdeli and the Loss, Trauma, and Emotion lab under the guidance of Dr. George Bonanno at Columbia University, allowing me to deepen my expertise.

I have lived in four U.S. states (California, Ohio, New York, and Hawaii) and three countries (Israel, the U.S., and Colombia), including immersive experiences with Indigenous and sustainability-focused communities. These experiences have strengthened my cultural competence, adaptability, and dedication to fostering global connections. Being deeply embedded in different cultural contexts provided me with invaluable insights in shaping my approach to psychology and global mental health. Fluent in Hebrew, English, and Spanish (and

currently learning Arabic), I bring strong communication skills and the ability to engage meaningfully with diverse populations.

The ICP's focus on promoting psychology's impact within the United Nations framework resonates deeply with my passion for using psychological research and practice to address global challenges. I am particularly drawn to the opportunity to engage in NGO committees and the Psychology Coalition at the UN, where psychology informs critical discussions on mental health, resilience, and justice. With my background in culturally sensitive interventions, peacebuilding efforts, and innovative therapies, I hope to contribute by bringing a nuanced understanding of mental health in conflict-affected regions and a commitment to evidence-based solutions that uphold human rights. This internship represents an ideal alignment of my skills, values, and aspirations to advance global well-being and sustainable development on a global scale through psychology.
